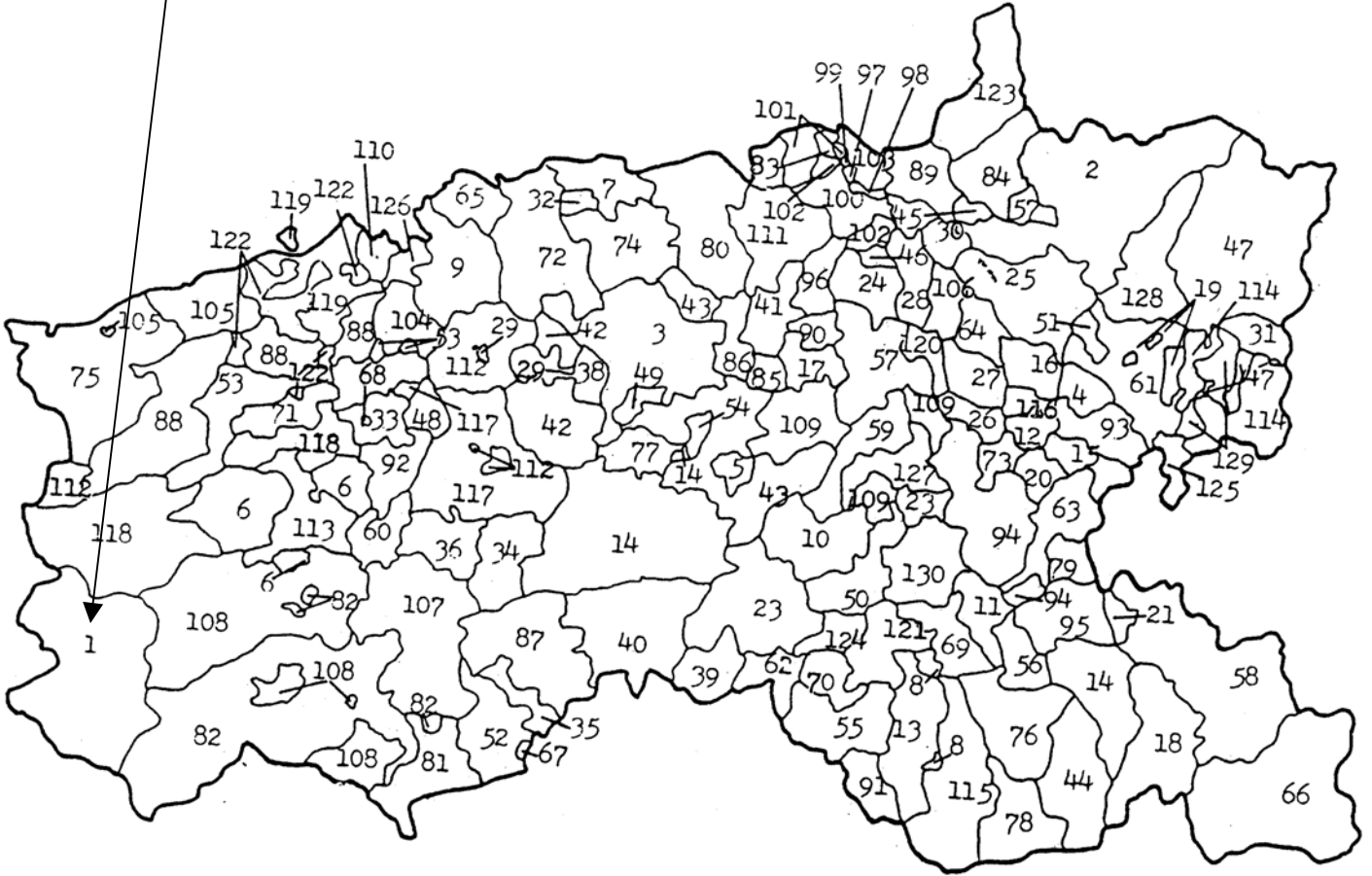

This parish is situated in the N.W. part of the Barony of Glenquin, and is bounded on the N. by Rathronan Ph.; on the E. by Monagay Ph.; and on the S. and W. by the County of Kerry.

This parish contains 40 Protestants and 5,000 Roman Catholics, according to the information furnished by the Clerk of the Church and by the Revd. Daniel Lyddy, P.P., who resides in the townland of Dromtrasna Collins. It embraces 18,149 a. 3 r. 20 p. statute measure, including 87 a. 1 r. 25 p. of water. Fairs are held in the town of Abbeyfeale on the 24th September, and in the townland of Abbeyfeale West on the 29th June. The crops generally sown are potatoes, oats, and a little flax. The oats are generally carried to Glin for sale, where they are purchased and taken to Limerick for export. The soil in general is bad and marshy. Lime is chiefly used as manure, and is brought principally from Castle Island (Co. Kerry) and Askeaton (Co. Limerick).

Abbeyfeale Village -- J. O'D.

The village, which gives name to the parish of Abbeyfeale and to the townlands of Abbeyfeale East and West, derives its name partly from the River Feale, and partly from the ruins of an old abbey standing in the village, having a burial ground and also the ruins of an old chapel. (N.B. No vestige of the abbey remains at present; but its site is shown in the graveyard near the new Roman Catholic Chapel. The old chapel has also disappeared except for a small portion of it which has been incorporated in the new Roman Catholic Chapel erected on its site.) According to Allemant, Archdall, and Gough, the abbey was a Cistercian foundation, founded in the year 1188 by one of the O'Briens; but it does not seem to have been either important or extensive.

The village stands in the western verge of the parish, on the left bank of the River Feale, and on the Mail Coach Road from Limerick to Tralee. The river is here spanned by a bridge, and separates the parish from the county of Kerry.

About 1 Irish mile to the north-west of the village, near the bank of the River Feale, stand the ruins of Port Castle, an ancient Geraldine stronghold. The building is 40 feet long by 30 feet 10 inches wide, on the outside, and its walls are 6 feet thick; but its architecture is very rough and mean. The arch over the ground floor remains; it is pointed, and is 15 feet in height from the level of the floor. As it stands at present, the castle is about 20 feet high; but it was probably much higher.
