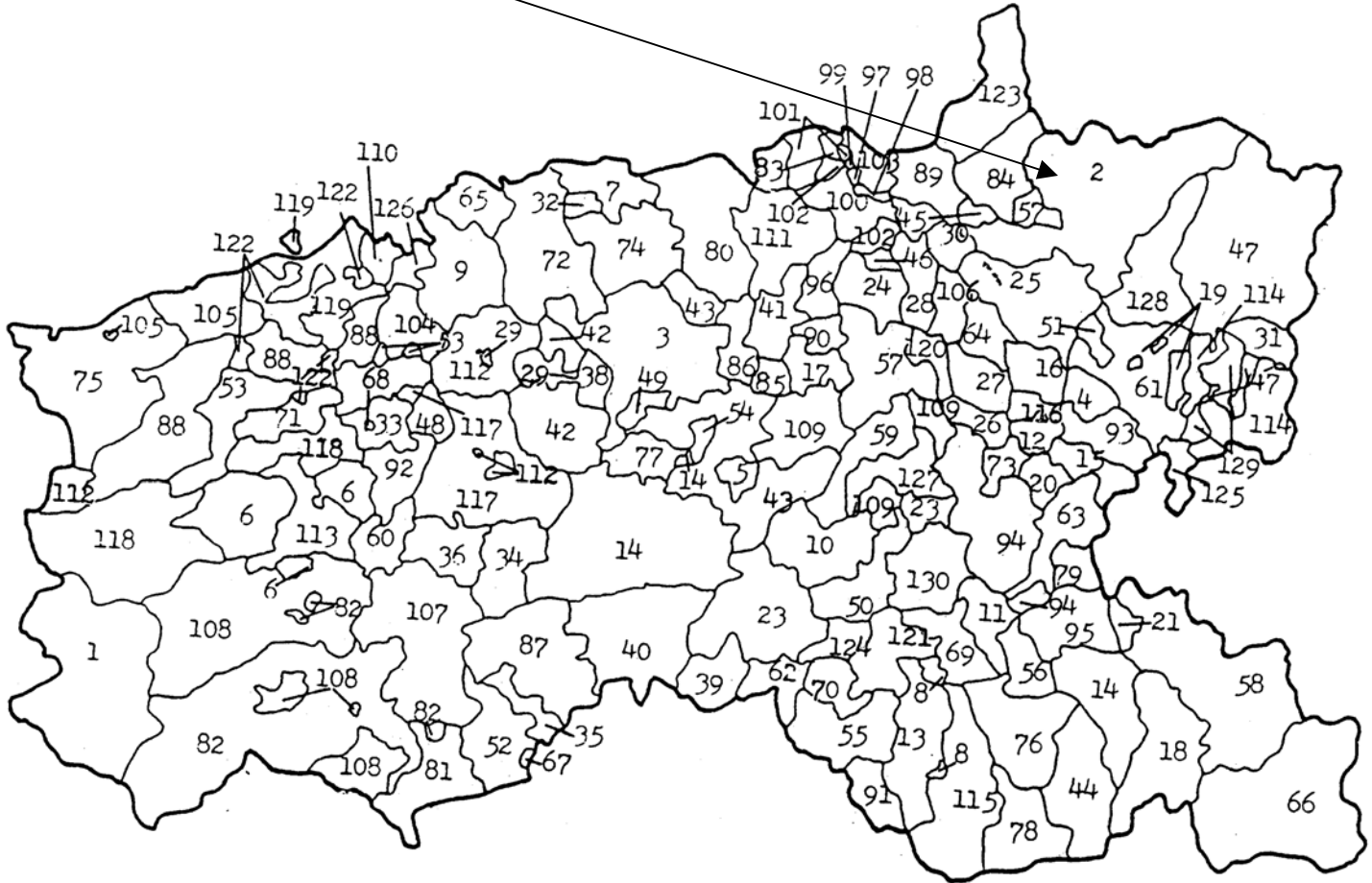

In 1839 all the pupils were Roman Catholics.
