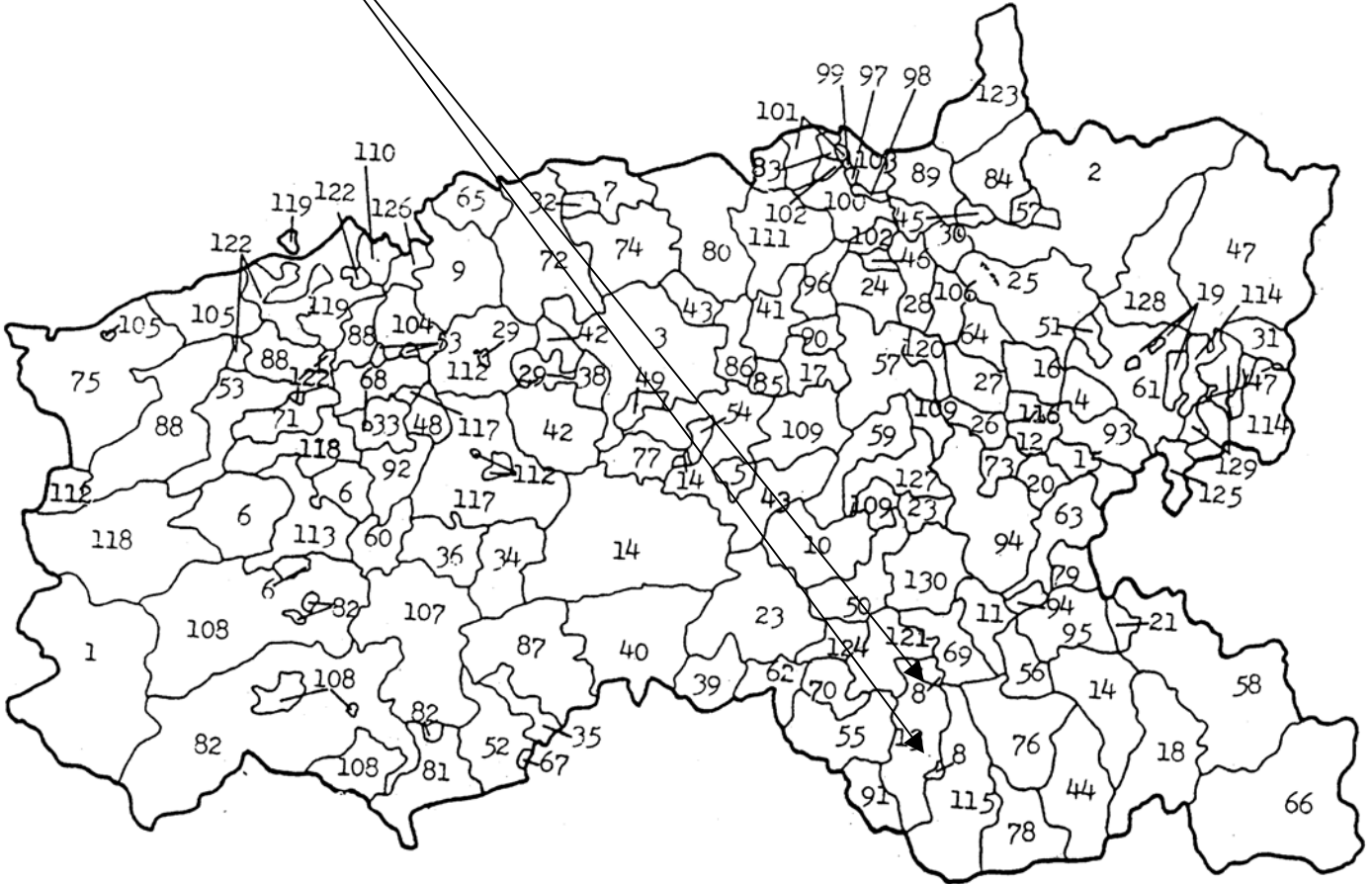

Bounded on the N. and E. by the Ph. of Kilbreedy, and on the W. and S. by Ballingaddy Ph. Comprises the townlands

of Ardpatrick, Mount Coote, and Riversfield, and lies along the northern skirt of the Galtee Mountains, about $4\frac{1}{2}$ miles S.E. from Kilmallock.

Contains 623a. 3r. 38p. statute measure. All arable land. There are two Gentlemens seats in the parish. The residence of Mr. Chidley Coote stands in Mount Coote Td., and in the W. of Riversfield Td. is the residence of Thomas Weldon, Esq. In Ardpatrick Td. are the ruins of an ancient religious foundation, said to have been established by St. Patrick.

Situated in the S.E. of the parish, and is bounded on the N. and W. by the tds. of Baunmore and Baunatlea, in Ballingaddy Parish, and on the E. and S. by the tds. of Sunville Upper and Toor, in the parish of Particles.

Is the property of Chidley Coote, Esq., and contains 154a. Or. 30p. statute measure. All arable land. The north boundary is the centre of a road. In the W. of the td., adjacent to the boundary, there is a fort. In the centre of the td. stand the ruins of an old church and a burying-ground, the ancient Patrician foundation.

Situated in the N. of the parish. Is bounded on the N. by the tds. of Gibbonstown and Bohard, on the W. by Millmount Td., on the E. by Tankardstown and Tullyleak Tds., and on the S. by the tds. of Milltown and Riversfield.

Is the property of Chidley Coote, Esq., and contains 310a. 1r. 29p. st. measure. All arable land. In the N. of the td. is a neat house, with suitable offices and beautifully ornamented with trees. This is Mount Coote House, the residence of Mr. Coote. In the south, or front, of the house, is an artificial pond. Interspersed through the townland are several neat plantations.

Riversfield (contd.)

Situated in the N. of the parish. Bounded on the N. by Tullyleak Td.; on the W. by Mount Coote Td.; on the E. by Bawnagh Td.; and on the S. by the tds. of Flemingstown and Ballingaddy N.

Is the property of Chidley Coote, Esq., and contains 159a. 1r. 19p. st. measure. All arable land. In the W. of the td. there is a neat house, with offices and an orchard attached, the residence of Thomas Weldon, Esq. The fences through the td. are neatly planted with trees. The centre of a river forms the W. and S. boundaries. The N. boundary is the centre of a road. Nothing of antiquity.

Ardpatrick Well -- Local 5

In the S. of Ardpatrick Td.

This is a Blessed Well.

Ardpatrick Castle Ruins -- Local 6

On Ardpatrick Hill.

This was a lofty Round Tower, the greater portion of which fell down a few years back.

Ardpatrick Church and Burying-ground -- Local 7

On the summit of Ardpatrick Hill.

The church, in ruins, is identified by the inhabitants with the ancient Patrician foundation.

Ardpatrick Hill -- Local 8

In the centre of Ardpatrick townland.

On its summit stand the ruins of the ancient Patrician foundation. By an Inquisition of the time of Queen Elizabeth it was found that this hill was anciently granted to the coarbsp of the church, and that the office of coarb had from time immemorial been vested in the sept of the Langanes, by one of whom it was then held. On the summit of the hill is also a Trigl. Station, and at its foot a large and handsome Chapel has been lately erected.

A splendid house, with offices and an extensive and beautiful demesne, and having an ornamental pond in front of the house. The residence of Chidley Coote, Esq.

This lake, otherwise Mount Coote Ponds, runs through Mount Coote demesne, in front of Mount Coote House.

Mount Coote Moat -- Local Name 11

In Mount Coote Townland.

Situated to the E. of Mount Coote House. Mount Coote takes its name from this little moat.

Riversfield House -- Local 12

In Riversfield Td.

A neat, two-storied house, with offices and a well-planted demesne. The residence of Thomas Weldon, Esq.

Riversfield Bridge -- Local 13

On the boundary with the townland of Ballingaddy Nth.
