This parish is situated in the North of the County, in the Barony of Connello Lower.

According to Fitzgerald in his History of Limerick, it is a Vicarage in the Diocese of Limerick. It is of an oblong form. Its greatest length, from the Td. of Court Browne in the N. to Ballynacaheragh in the S. (passing through the town of *skeaton), is 5 statute miles; and its greatest breadth from Coolrahnee in the W. (from the point where the Askeaton and Tarbert road crosses the parish boundary) to Ballyengland in the E. (at the point where the Limerick and Askeaton road crosses the boundary) is 3½ statute miles.

Askeaton Castle ruins

Situated on an island at the town of Askeaton, in the td. of Aghalacka.

Part of the N. and W. walls are standing and perfect. Height about 90 feet. The other walls are down. The mode of ascent was a spiral staircase, the lower part of which is perfect. When this castle was attacked by the English forces, the Earl of Desmond with his family retired to Carrigaholt, leaving a train of gunpowder concealed under the E. part of the castle, which exploded and reduced the castle to its present condition.

Askeaton Flour Mills -- Local

Situated on the W. bank of the River Deel, in the S. end of Askeaton Td.

It is a rectangular building 66 feet long and 48 feet broad and 6 stories high. It is worked by one breast shot water wheel, diameter 14 feet, breadth 11 feet, and fall 2 feet, being 30 horse power. It was built in 1825 by John Hewson, Esq., Castle Hewson, Askeaton.

Situated in the Td. of Askeaton, on the E. bank of the River Deel.

There are two Flour Mills here joined together. One of

those mills was built about 45 years ago by Mr. Studdert, Askeaton. It is a rectangular building, 3 stories high, and worked by one water wheel, which is three quarter breast shot, its diameter 18 feet, its breadth 4½ feet. The other mill was built in 1832 by Paul Erson, the present proprietor. It is also 3 stories high and worked by an overshot water wheel, the diameter of which is 14 feet and breadth 5 feet. There is a store attached to the mills.

It is pleasantly situated on both sides of the river, and contains a Church, a Chapel, the ruins of an Abbey, a Petty Sessions Court House and a Police Station containing 5 subconstables and a sergeant. It has 14 Publicans, an Innkeeper, 9 Bakers, 9 Carpenters, 2 Nailers, 11 Butchers, 6 Smiths, 7 Taylors, 6 Weavers, and 6 shopkeepers. There is a small weekly market held here.
