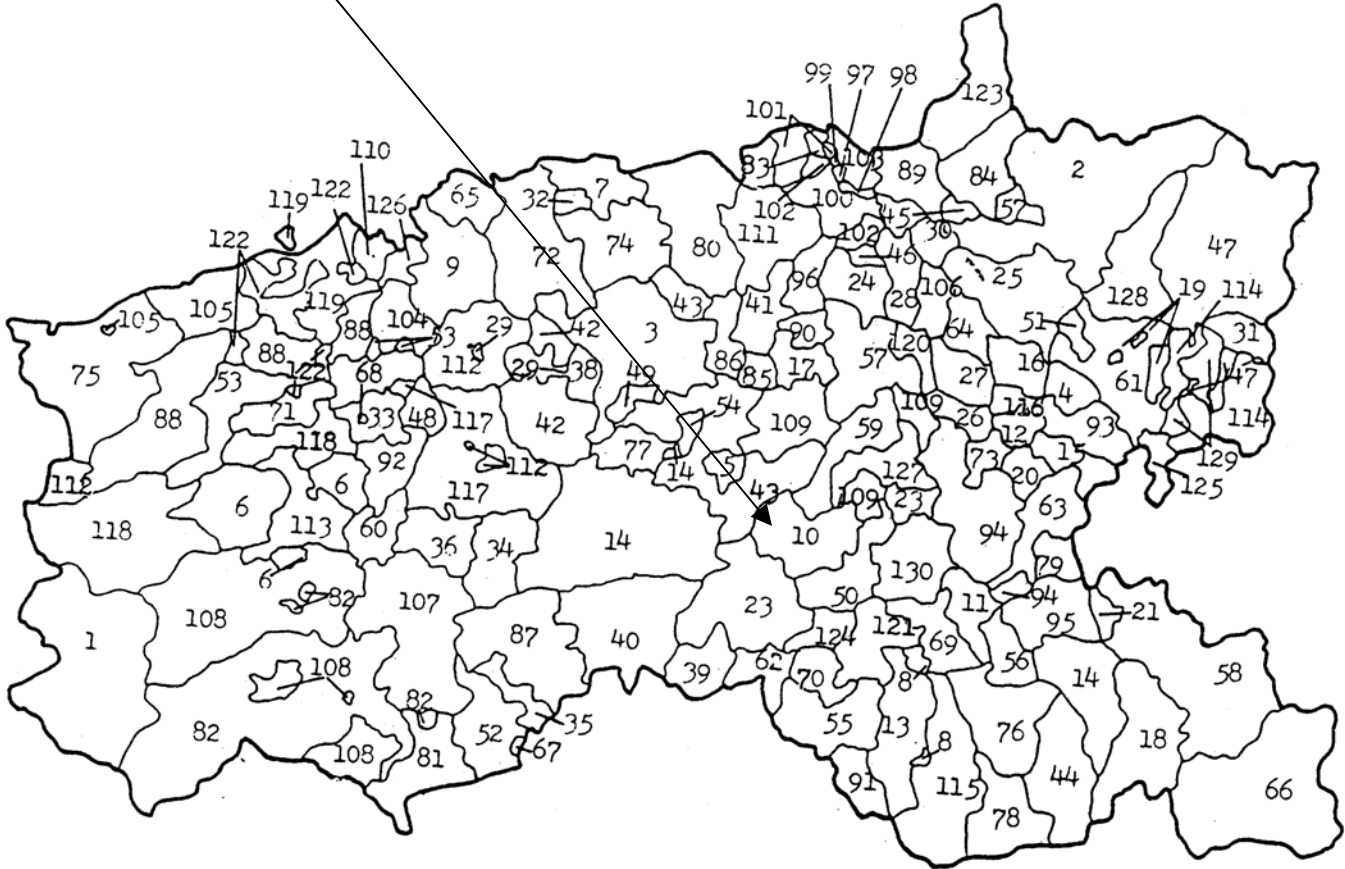

- The property of Mr. Ivers of Castle Ivers, containing 492 a. 2 r. 16 p. of arable land. In the S.E. boundary of the td. is Athlacka Bridge. In the S. of the td. is an old ruin.

In the S. extremity of the parish. Bounded on the N. by the tds. of Athlacca S. and Rathcannon; E. by Rathcannon; W. by Bruree Ph.; and S. by the parishes of Bruree and Dromin.

The property of Mr. Barry, Cherrygrove, containing 399 acres of arable land. In the W. part of this td. is a Trigl. station called Cloonbrien. There are also two ancient forts in this td., one in the N. called Lisheengorm, and the other in the S.

The property of Mr. Ivers of Castle Ivers, containing 222 a. 2 r. 3 p., including about 16 acres of rough pasture and the remainder arable land.

The property of the Revd. Robert Croker, Athlacca Glebe, containing 22 a. 3 r. 31 p. of a Demesne. In this td. is a Glebe House. In the N. part there are also a Church and Burial Ground.

The property of Mr. Ivers, Castle Ivers, containing 154 a. 2 r. 25 p. of arable land. In the E. boundary of this td. is a Trigl. Station called Glenma, and there is also a large fort of uncommon size called Glenma Fort.

Bounded on the N. by the phs. of Glenogra, Tullabracky and Monasteranenagh; E. by the phs. of Monasteranenagh and Dromin, and by the tds. of Ballincurra and Ballinculloo; S. by Dromin Ph.; and W. by the tds. of Cloonbrien, Athlacka S., Glebe of Athlacka S., and Coolboy.

The property of Archdeacon Maunsell of Limerick, containing 2129 a. 2 r. 3 p. of arable land. In this td. are 4 Trigl. Stations, 2 in the E. part called Rathcannon and Knockdarnaun, one on the N. By. called Rathcannon N., and the fourth in the W. part called Rathcannon No. 2. There are also 10 ancient forts, 5 of which are in the N.W. part, 2 in the W. part (one of these named Lisheengorm), 2 in the central part, and one in the S. named Knockdarnaun Fort. Rathcannon Castle, in ruins, is in the E. part of the td. Rathcannon R. C. Chapel is in the W. part, and Clogher West Bridge in the S. of this td. with Dromin Parish.

The property of Simon Rose, Esq., Limerick. Containing 353 a. 2 r. 20 p. of arable land. In the S.W. part of this td. is an ancient fort called Rosstemple Fort. There is another fort near the W. boundary.

In the N. extremity of the parish. Bounded on the N. by Croom Ph. and Rosstemple Td.; W. by Rosstemple; S. by Athlacka N. and Coolboy; and E. by Glenogra Ph.

The property of Mr. Bolster, Tullerboy. Contains 583 a. 1 r. 29 p. including about 36 acres of rushy pasture and 30 acres of rough pasture; the remainder arable land. In the S. of the td. is a Trigl. Station called Tullerboy, and there are two forts, one in the S.E. and the other in the S.W. In the S. end is Tullerboy Cottage, and about the central part is Tullerboy House.

Lissnaraha Fort -- Mr. Bolster, Farmer 14

Lios na Rátha. This name is composed of two synonymous terms Lios and Rath, both meaning 'an earthen fort'.

 The peasantry of this name style themselves Howard; but the gentry go by the name Ivers. The Irish name is O hIomhair.

 The ruins of an ancient castle adjoining Castle Ievers or Tullerboy House, the residence of R. Ivers, Esq.
- Brunies Holy Well -- Local 25  
 Tobar Bhronaigh, St. Bronach's well.  
 Situated in the N.E. end of the Td. of Athlacka and 100 links from the Old Church of Athlacka.  
 This is a Holy Well where the inhabitants perform or make rounds on all Good Fridays and on Sunday mornings.
