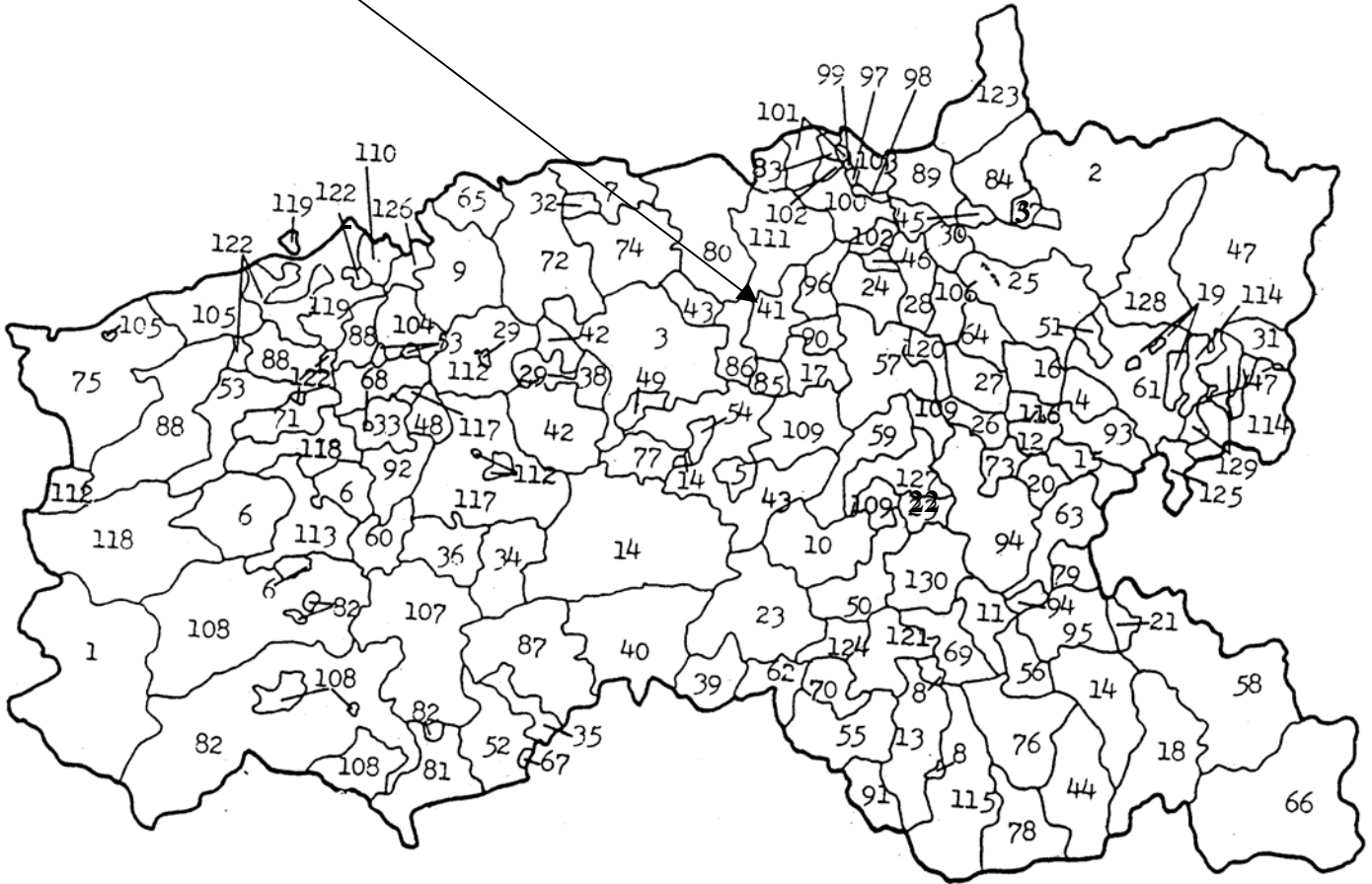

This parish is situated in the north of the County. It is of an irregular form. Its greatest length from Rootiagh td. in the N., at the point where the road from Limerick to Croom crosses the parish boundary, to Ballinveala td. in the S., where the same road crosses the parish boundary, is $3\frac{1}{4}$ statute miles; and from the td. of Markbrook in the E. to the td. of Ballinroche North in the W. is 2 st. miles.

The parish contains 3010 statute acres. The land is everywhere good, and about $\frac{2}{3}$ are under tillage, the chief crops being wheat and potatoes. The ruins of the old parochial church, which was destroyed during the Wars of the Confederation, stand in the Glebe. In 1834 the population of the parish consisted of 21 Protestants and 1,449 Catholics.

Fitzgerald, Esq. on a lease of 3 lives at £2 7s. per acre, who again sublets to 2 tenants at will at £2 18s. per acre. Co. Cess per acre from 2s.4d. to 3s. Tithe per acre 1s.9d. Size of farms - 17 to 52 acres. Soil light, producing wheat, oats and potatoes. There is a bog on this td. There are also 2 ancient forts. Prevailing Names - Dempsey and O'Brien.

Co. Cess per acre from 2s.4d. to 3s. Tithe per acre 1s.9d. Size of farms - 9 to 30 acres. Soil light, producing wheat, oats and potatoes. Fuel scarce. There is one fort here. Prevailing Names - Herbert, Quirke and Caranagh.

This townland is situated in the East of the parish, and contains 160 acres.

It is the property of William Christmas, Esq., Co. of Waterford. Agent, Mr. Allen, Dublin. Middleman, George Tompkins, Esq., Thomas St., Limerick, on a lease of lives renewable for ever. He sublets to 1 tenant on a lease of 99 years at £1 5s. (Irish currency) per acre. Co. Cess per acre yearly from 2s.6d. to 3s.10d. Tithe per acre yearly 1s.8d. Size of farm - 96 acres 2 roods, plantation measure. Soil partly light and subject to floods, producing wheat, oats and potatoes. Fuel scarce. There is here a Roman Catholic Chapel, built in 1832 at the expense of the parish, and capable of accomodating 500 persons.

Cess per acre 2s.4d. to 3s. Tithe per acre, 1s.8d. Size of farms - 3 to 12 acres plantation. Soil loamy, producing potatoes, wheat and oats. Prevailing Names - Ryan and Flannigan. Barnakila River waters this td. Dooneen House, the residence of the proprietor, is 3 story high and was built in 1820. Attached are a garden, a good set of stables, and some trees. There are 2 forts in the td.

Cess per acre yearly 2s.4d. to 3s. Tithe, 1s.8d. per acre. Size of farms - 2 to 11 acres. Soil argillaceous, producing wheat, oats and potatoes. Fuel scarce. Prevailing Names - Whitlew and Grady. There is a burial ground in this td.; there are also the ruins of the old parochial church.

Barnakyle House, the residence of the proprietor, with a plain garden, a good square of offices and some trees, stands here. It was erected in 1770 by Francis Green, Esq. There are 3 forts in this townland.

Cess per acre yearly from 2s.6d. to 3s. Tithe per acre 1s.8d. Size of farms - 140 acres plantation. Fuel scarce. Prevailing Names - Dundon and O'Brien. Jockey Hall (house) is at present occupied by Patrick Dundon. It was built in 1780 by James Hewson, & is 3 stories high.

Tithe per acre 1s.6d. Size of farm - 84 acres plantation measure. Soil argillaceous, producing wheat, oats and potatoes. Fuel plentiful. Prevailing Names - Halvey. Richmondville House, 2 stories high, with a good set of offices and a garden, is situated here. The house was repaired in 1822, and is occupied by Mr. Wallace.

Tithe 2s.3d. by Composition. Size of farm - 64 acres plantation. Soil loamy, producing wheat, oats and potatoes. There is a bog on this townland. Prevailing Name - O'Callaghan.

2s. to 2s.6d. per acre. Soil argillaceous, producing wheat, oats and potatoes. Fuel plentiful. Prevailing Name - Carmody. In this townland is a good house, occupied by the Revd. Mr. Jones. It was built in 1814, and has attached some ornamental ground and some trees.

This townland is situated in the eastern extremity of the parish, and contains 37 acres.

It is the property of the Representatives of Edward Villiers, Esq. Agent, George Briscoe, Esq., Piltown, Co. Kilkeny. It is let to 1 tenant at will at £2 5s. per acre. Co. Cess per acre yearly 2s.6d. to 3s.4d. Tithe per acre 2s.3d. Size of farm - 22 acres. Soil loamy, producing wheat, oats and potatoes. Fuel scarce. Prevailing Name - Kirby. Marlbrook Cottage, with a good garden and set of offices, is situated here. It is the residence of Mr. John Kirby. There is one fort here.

It is a beautiful house, situated on an eminence, and is 2 story high. A good garden and orchard are on the south side of the house, and the demesne is ornamented with trees.

This house was built in 1770 and is 2 stories high. Its style of architecture, though plain, is chaste. Attached to it are an extensive demesne, a good garden, and a range of stables.

It is situated on a gentle declivity, and is 2 story overground, 1 story underground. It was built in 1820. Attached to it are a large orchard, some trees, and ornamental ground.

It is 2 stories high, and was repaired in 1839. It is unoccupied at present.

Situated in the townland of Jockeyhall, in the south-eastern part.

This is an old dilapidated house, occupied by a Dairyman. To the west of the house are an orchard and some planting.

Ashfort House -- Local 23

It was built in 1814, and is falling rapidly into decay. Annexed to it are an orchard and garden, with a few trees and some ornamental ground.

Marlbrook House -- Local 24

Situated in the N.E. of the townland of Marlbrook. The residence of John Kirby, Esq.

This is a small house, with a large garden annexed.

Prospect Hall House -- Local 25

In the townland of Jockeyhall. The property of Mr. Tuthill, Faha.

It is rented and occupied by a Mr. Dundon. The house is 2 story high and much dilapidated. The offices are also falling into decay. Annexed to it are 2 large orchards.

- Shanclough House -- Local 26
 Situated in the south of the townland of Shanaclogh.
 This is a small farmhouse with a planting to the east of it.
- Dooneen Bridge -- Local 27
 On the boundary between the townlands of Dooneen and Ashfort.
 This bridge, which is over a small stream, on the line of road connecting Bruff and Limerick, had formerly two arches; but it was taken down and rebuilt in 1837, and has but one arch now.
- Turrethillfort -- Local 28
 Situated in the north of the townland of Greenmount.
 This fort is enclosed by 3 parapets, and is about 3½ chains in diameter.
- Lissard -- Local 29
 Lios Árd, high fort. J. O'D.
 Situated in the south of Greenmount td.
 This fort consists of 1 parapet, and is about 2 chains in diameter.
- Crecora Church Ruins -- Local 30
 Situated in the Glebe of Crecora.
 The east gable of this ruin is entirely down. About 16 feet in height of the side walls remain. The west gable is standing. The church is of a rectangular shape, about 34 feet long and about 22 feet broad. The graveyard is spacious, and some distinguished families seem to have been interred here, as appears from the number of vaults.
- Ballinveala Castle Ruins -- Local 31

 Situated in the townland of Ballinveala.
 This old castle is of an oblong form, and the walls appear to stand at their original height. Nothing of its history is retained by the peesantry.
- Crecora R. C. Chapel -- Local 32
 In the north-east of the townland of Ballinveelish.

This chapel consists of a nave, transept and sanctuary, and was built in the year 1832 at the expense of the parishioners. It is capable of accomodating about 500 persons.
