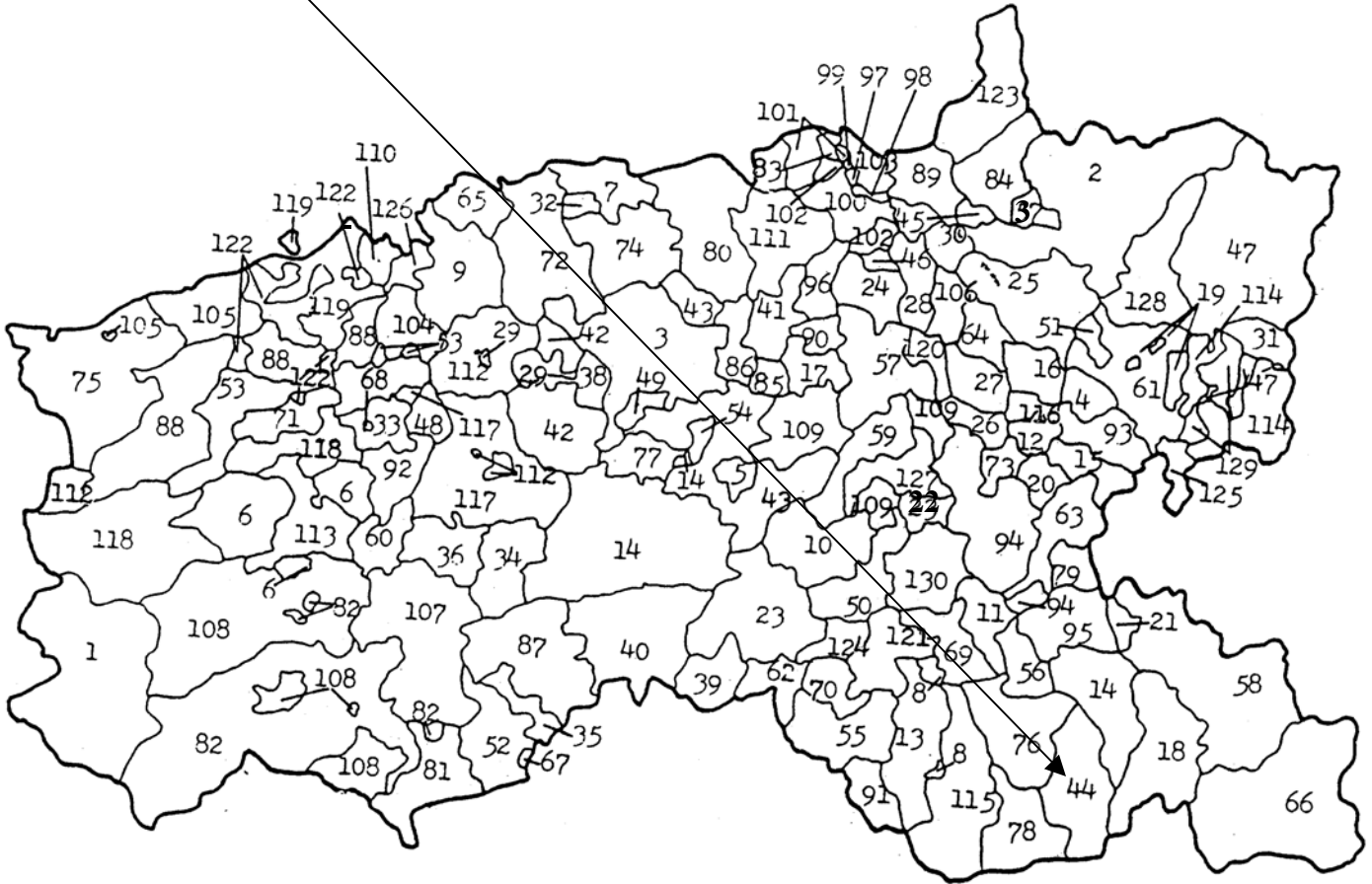

- Contains 6712 acres, st. measure. The parish in general is a mixture of arable and mountain, and there are roads through it in every direction and several small streams. Interspersed through it are several plantations of trees, a few ancient forts, and a number of neat houses. Ballinacourty House is situated in Ballinacourty Td., in the southern part of the parish.

- Is the property of the Hon. C. Butler, Wandsford, and Frederick Bevan, Esq. Contains 494 a. 1 r. 33 p. st. meas., generally arable land with some portions of rough pasture interspersed. There is one road bearing nearly E. and W, and there are several houses interspersed.

West of the td. is a large wood, and central of the td. there is a road bearing E. and W. There is one fort in the E. of the td. There is a stream bearing S. across the td., nearly central, and there are a few houses thinly interspersed.

Central of the parish. Bounded on the N. by Rypplagh; W. by Ballynacourty; E. by Tully; and S. by Spittle.

Is the property of Michael Bourke, Esq., Justice of the Peace, Ballynacourty. Contains 489 a. 2 r. 16 p., st. meas. A quarter of the td. in the western part is a mountain; the remainder is arable land, interspersed with some portions of rough pasture. Central of the td. there is a well called Tobernagreckin. There is one old road bearing N. & S. across the townland.

In the S. of the parish. Bounded on the N. by Ballynacourty and Spittle tds.; on the W. by Garryarthur; E. by Darraghbeg; and S. by Graigue and Killeloony.

Is the property of Frederick Bevan Esq., and contains 485 a 3 r. 24 p. st. meas. Nearly $\frac{1}{2}$ the townland in the southern part is wood and mountain; the remainder is arable land. Somewhat to the N. of the td. there is a road bearing E. and W. across the td., and S. of this road, in the eastern part, stands Darragh House. east of which stand the ruins of Darragh Old Church in a graveyard. Interspersed there are several plantations.

Quarter of the td. in the southern part is a mountain; the remainder is arable land, interspersed with rough pasture. Somewhat to the N. of the td. there is a road passing E. and W. There are a few houses interspersed. The E. and N. boundaries - the centre of a stream.

Is the property of H. C. Butler. Contains 1094 a. 3 r. 32 p. st. measure. Quarter of the td. in the western part is wood and mountain; the remainder is arable land. Somewhat towards the East of the td. there is a road bearing N. and S. in a curving direction across the td. There are 2 forts in the td., one near the south boundary, the other near the north boundary. There is a stream running E. from the mountains.
