This portion of the parish is about 7 miles long by 5 broad, and a great portion of it is mountainous & hilly land. Its principal road is that leading E. & W. through its centre from Cappamore to Cappawhite. A few minor roads traverse it in different directions.

But when she returned, the fort was all covered with distaffs, and she was unable to recognise the one that marked the site of the gold. It is from this incident that the fort is said to have obtained its name.

This hole, which is though to be a Danish structure, is about 14 feet deep and 8 feet wide. It is circular, and made of stones. It is on a heathy mountain.
