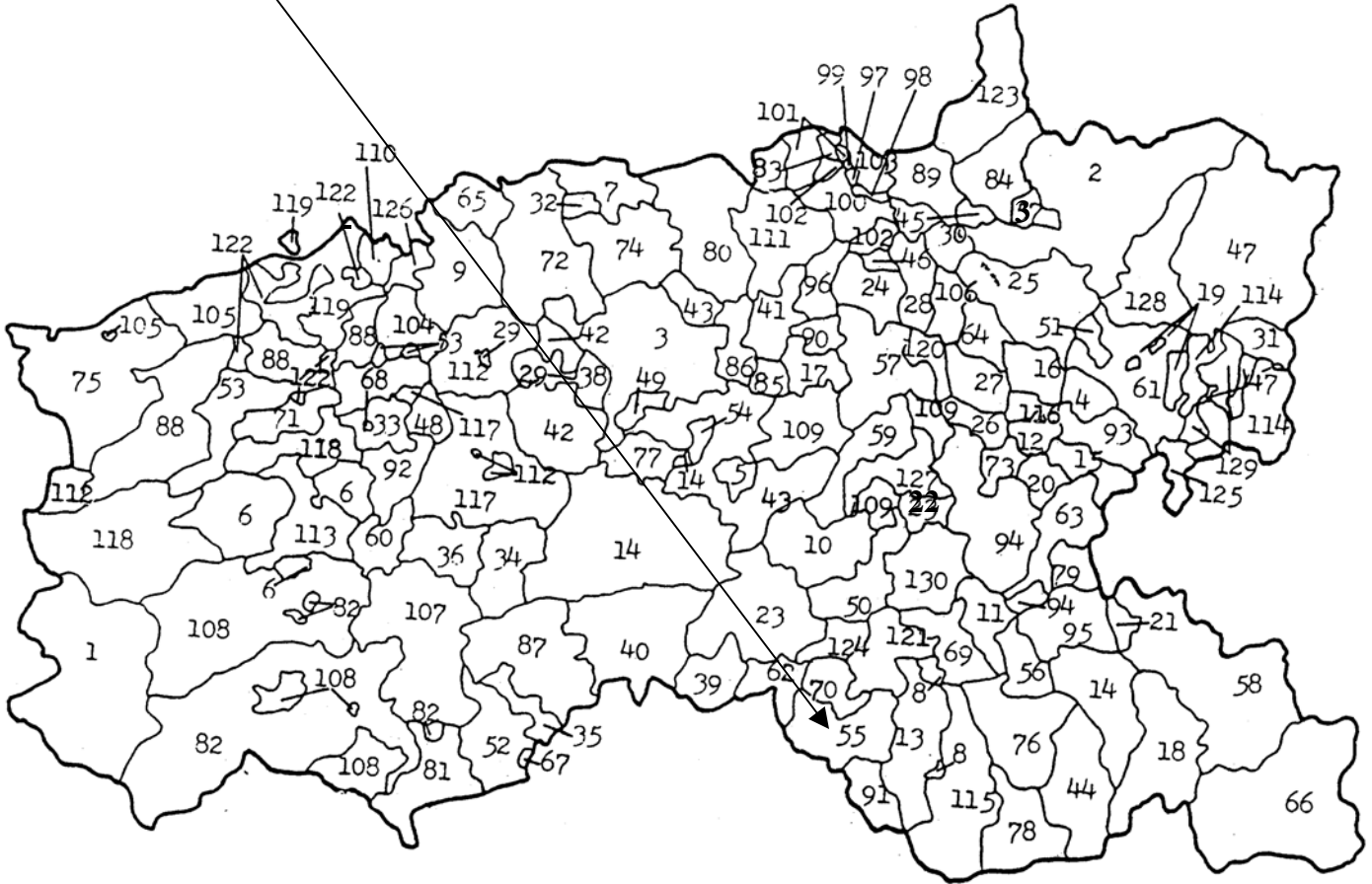

St. Eimhin or Eifinn, who had his church here, was a contemporary of St. Kevin of Glendalough. The full name of this place was Cill-Eimhin or Killeffin.

It is bounded on the N. by the Ph. of Kilbreedy Minor and the Liberties of Kilmallock; W. by the Phs. of Kilpeacon and Charleville; E. by Ballingaddy Ph.; and S. by the Ph. of Effin in the Barony of Coshlea.

Contains 3,287 acres, statute measure, all arable land, well cultivated. There are roads through the parish in all directions. There are several ancient forts and two R. C. Chapels, one in Garrynderk S., the other in the td. of Tobernea W. There is a Gentleman's seat in the West of Garrynderk Td. The only remains of antiquity are the forts, the ruins of Tobernea Castle in the W. of Leagane Td., and the ruins of Effin Church in the Glebe of Effin.

It is the property of Henry Dean Grady, Esq., Dublin, and contains 734 acres, all arable land. There are 2 roads bearing E. and W. across the td., one in the North, and the other in the South; the latter runs in a curving direction. In the South of the td. are the ruins of an old church and graveyard. The road from Kilmallock to Charleville crosses the td. on the North.

This Glebe is central of the parish. Bounded on the North, East and West by Effin Td., Barony of Coshma, and on the S. by Effin, Barony of Coshlea.

It is the property of the Revd. Mr. Gabbett, Cahermurphy, Co. Clare. It contains  $3\frac{1}{2}$  acres, all arable land. In the West of the Glebe are a graveyard and the ruins of an old church. The boundary of the Glebe is the road from Kilmallock to Charleville.

This townland is situated in the West of the parish. It is bounded on the N. by the tds. of Mountblakeney and Ballynagoul; W. by Ballincolly td.; E. by Effin td.; and S. by the td. of Garrynderk South.

It is the property of Sir Edwd. O'Brien, Dromalane, Co. Clare. It contains 501 acres, all arable land. One road, bearing E. and W., is the boundary between the two Garrynderks. There are 5 ancient forts in the td. There is a R. C. Chapel on the north side of the above mentioned road. There are a few neat plantations of trees.

It is the property of Mr. Bennett, Cork, and contains 358 acres, all arable land. In the Nth. of the td. there is a road, the north side of which is the boundary between the two Garrynderks. In the W. of the td. is a Gentleman's seat, called Maiden Hall. There is a fort convenient to the house, which is surrounded by water. Nearly in the centre of the td. is a Trigl. Point, 285 feet above the level of the sea.

It is the property of Lord Lisle, England, and contains 270½ acres. In the N.E. and S.E., adjacent to the boundary, there are 2 small portions of rough pasturage; the remainder is arable land. N. of the td., near a road, the centre of which is the boundary, there are a few houses. There is one Trigl. Station, Brickfield Cong. Point, 489 feet above the sea level.

It is the property of Lord Lisle, England, and contains 152 acres, all arable land. In the S.W. of the td. there is one fort, and on the N., near a road, are the ruins of Tobernea Castle, nearly in the shape of a fort. The townland is bounded by roads that lead to either Kilmallock or to Charleville.

It is the property of Colonel Gibling, Cork, and contains 438 acres, all arable land. There is one road bearing E. and W. about the centre of the td. There are 2 forts N. of the above-mentioned road. In the West of the td., close to the boundary and near a road, there is a Roman Catholic Chapel.

This td. is situated in the N.E. of the parish. It is bounded on the N. by the td. of Portane; W. by the tds. of Thomastown and Tobernea Middle; E. by the tds. of Ballingaddy and Kilmihil; and S. by Garranekeagh and Leagane tds.

It is the property of Lord Lisle, England, and contains 465 acres, all arable land. There is one road bearing N. and S. across the N. part of the td.; the centre of this road is part of the west boundary. There are a few houses interspersed. The road mentioned above leads from Kilmallock to Charleville.

It is the property of Colonel Giblings, Cork, and contains  $211\frac{1}{2}$  acres, all arable land. In the S.E. of this td., close to a road, the centre of which is the boundary, there is a well called Tobernea Well. The east boundary is the centre of the road from Kilmallock to Charleville, which road is also the southern boundary.

It contains 1,980 acres, statute measure. All is good arable land, well cultivated. There are several roads leading in all directions through the parish. There are a few ancient forts and one Gentleman's seat, situated in the Td. of Newpark. The most elevated part of the parish is N. of Brickfield, and is 487 feet above the sea level. There are 2 portions of flooded land, one in Brickfield, and the other in Ballyshonikin.

About the centre of the td. are two wet or marshy spots. Something to the S. there is a cross-roads, one bearing East, the other North and South, through the townland. A portion of the south of the townland is subject to flooding.
