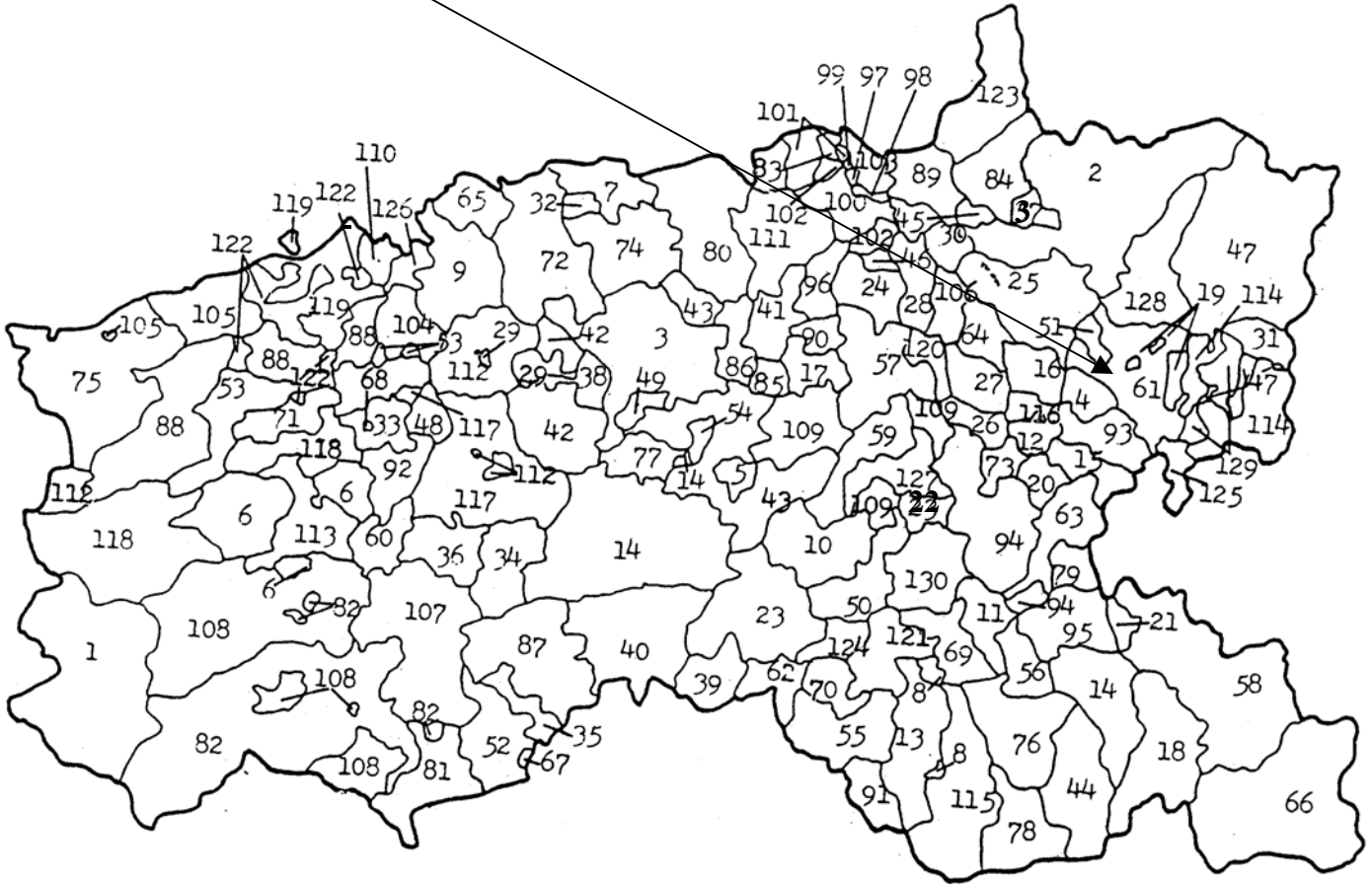

This parish is situated about 9 miles S.E. of the City of Limerick. It is bounded on the E. by the parishes of Ballynaclogh, Cluggan and Templebredon; N. by the phs. of Tuogh and Doon; W. by Aglishcormick Ph. and by Grean Ph. in Clanwilliam Barony; and S. by Kiltteely Ph. and the Co. Tipperary.

This parish is about $3\frac{1}{2}$ miles long and $2\frac{1}{2}$ miles broad, & contains 5,680 acres. It consists of good land, and is very level except Pallas Hill, Knockgrean and Knockderk, which are beautiful green pasturages, famed for their splendid prospect. The parish is well supplied with roads. In its N. end is the New Line from Limerick to Tipperary, and through it leads another from Cappamore to Pallas, etc.

Three of the 5 houses are 2 story high, including the School House, which was built in 1820 at £300 by the Erasmus Smyth Board. There are 50 to 20 boys and girls attending daily, of whom 10 are Protestants, the rest Roman Catholics. The Master is paid £20 per annum from the above mentioned Board, and is provided with an house and garden.

Situated in the extreme S.E. point of Ballytarsna Td., and about 2 chains N. of the road from Pallas to Herbertstown.

There is a small valley of this name. It is concave and about 2 chains in diameter and 20 feet deep, with some water in it in winter, but dry and green during the summer.

Knock See Finn -- Inhabitants 6

Cnoc Suidhe Finn, hill of Finn's sitting.

Seefin occurs very often.

Knockseefin -- J. O'D.

Fingall's Table (Eng.) -- Inhabitants

Situated in the extreme S. part of Lackanaskagh and about 4 chains E. of Carrickanaffrin.

This is a small circular fort, about 20 feet in diameter and 2 feet high, which is placed on a smooth green hill of an oval shape and about 5 chains in diameter. This hill is very beautiful, and is so very elevated as to command an extensive view for several miles around it. Another such table can be seen about 20 miles from it on the County Clare mountain and parish of Kilseely.

Skagh a Pfreaghain -- Inhabitants 7

Sceach a' Phréachain, the crow's thorn.

Skaghaphreaghaun -- J. O'D.

Situated in the centre of Ardroe Td.

This is a fort nearly of a square form, about 2 chains wide and 4 feet high, composed of earth, with a level green surface and a few hawthorn bushes growing on its sides.

Cruckaun na guogh -- Inhabitants 8

Cnocán na gCuach, killock of the cuckoos.

The Cuckoos' Hill (Eng.) -- Inhabitants

Situated in the centre of the N. part of Killeenavera Td.

This is a small eminence about 4 chains in diameter. It is green, and around it is chiefly cultivated ground.

Patrick's Well -- Inhabitants 9

Tobar Phádruig, well of St. Patrick.

Patrick's Well -- J. O'D.

Situated in the S.E. point of Garrison Td., and about 40 feet N. of the road from Pallas to Oola &c.

It is a spring well of very good water with a small rivulet flowing from it.

Thobar Heela -- Inhabitants 10

Tobar Shíle, Celia's well.

Toberheela -- J. O'D.

Cecily's Well (Eng.) -- Inhabitants

Situated in Nicker Td., about 1 chain W. from the E. boundary, and about 2 chains S. of the road from Limerick to Tipperary.

This is a small spring well, about 2 feet wide, and of very good water.

Thobar a Ghaddie -- Inhabitants 11

Tobar a' Ghadaidhe, well of the thief.

Toberagaddy -- J. O'D.

The Thief's Well (Eng.) -- Inhabitants

Situated in the N.E. corner of Kilduff Td., about 3 chains E. of the road from Limerick to Tipperary.

Thobar a Ghaddie (contd.)

This is a spring well in a green field. It is about 3 feet wide and of very good water.

Thobar a yarrane baun -- Inhabitants 16

Tobar a' Ghearráin Bháin, well of the white horse.

Toberagarraunbaun -- J. O'D.

The White Horse's Well -- Inhabitants

Situated in the N.W. corner of Knocknacroy Td., about 1 chain S. of the W. boundary.

This well is about 3 feet wide, and is covered overhead. It is excellent spring water, and has a small rivulet flowing from it.

Thobar a Lunaght -- Inhabitants 17

Tobar a' Leamhnachta, well of the new milk.

The Milky Well (End.) -- Inhabitants

Toberalunaght -- J. O'D.

Situated in the S.E. corner of Knocknacroy Td., about 5 chains N. of Toberatassony, and in Glenatruhaun.

This well is 3 feet wide, of excellent water, and springs out from the Hill of Knocknacroy, which hill with the other hills joined to and in union with it is said to be the best supplied with water in Ireland. It is said to have 365 wells, or "as many as there are days in the year". When other wells are dry in summer, these, weeping in all parts, keep the surrounding plain watered.

Derk House -- Inhabitants 18

See Townland name. J. O'D.

Situated in the centre of Derk Td.

This house is the seat of Hiffernan Consadine, Esq., and was built some time before 1800, at the expense of about £6,000. It is 2 story high, and is seated on an eminence, from which is an extensive prospect.

Mount Catherine -- Inhabitants 19

See Townland name. J. O'D.

Situated in the middle of the N. part of Mountcatherine Td.

Mount Catherine (contd.)

This house is the seat of Henry Smithwick, Esq., and was built in 1760 at the expense of about £1,000. It is 2 story high.

Landscape -- Inhabitants 20
Landscape -- J. O'D.

Situated in Ballyvoneen Td., and on the S. side of the road from Limerick to Tipperary.

This house was built in 1824 by Michael Lloyd Apjohn, Esq., at the expense of about £600. It is 2 story high.

Sunville House -- Inhabitants 21
See townland name. J. O'D.

Situated in the centre of Sunville Td.

This house is the seat of Thomas Kerney, Esq., and was built in 1826 at the expense of about £3,000. It is two story high, and is seated on an eminence commanding a good view.

Corrig a neahy -- Inhabitants 22

Carraig an Éithigh, rock of the lie.

Carrickaneahy -- J. O'D.

The Rock of Lies (Eng.) -- Inhabitants

Situated in the W. end of Glen Td.

The face of this rock is about 60 feet high. It is nearly perpendicular, and on the top and on each of its sides is green pasture land. It is about 20 feet broad.

Corrig Chullom -- Inhabitants 23

Carraig Choluim, Columb's rock.

Carrickcollum -- J. O'D.

Situated in the S.E. end of Linfield Td., on the boundary between same and Bunavie Td., and about 4 chains S. from the road from Pallas Green to Caherconlish.

This rock is about 50 feet high, and is about 2 chains from one end to the other. Each of its sides and the top are planted with trees. The face, which is perpendicular, is ornamented with the strata, which grow upward like pillars and present a handsome appearance like a white-washed wall.

Corrig a Naffroinn -- Inhabitants 24

Carraig an Aifrinn, rock of the Mass.

Carriganaffrin -- J. O'D.

The Mass Rock (Eng.) -- Inhabitants

Situated in the S.W. corner of Lackanaskagh Td., and about 4 chains W. of Fingall's Table (See under Knockseefinn).

This rock, which is a beautiful glen, is almost circular, about 80 feet in diameter and 5 feet higher than the surface of the ground. It is said to have got its name from Mass having been celebrated on it by a Fr. O'Brien (whose relative is the present Revd. T. O'Brien Costelloe, P.P. of Abington). He celebrated Mass on the rock with the consent of the Bishop, who was sending him to France. After the Mass he exclaimed: "If you send me to France, send Knockgrean with me." And the Bishop, seeing him so fascinated by the beauty of the famous hill, permitted him to stay at home.

Thobar na Skehe -- Inhabitants 25

Tobar na Sceiche, well of the thorn bush.

The Hawthorn Well (Eng.) -- Inhabitants

Toberaskeha -- J. O'D.

Situated in the S. part of Nicker Td., and about 12 chains S. of Nicker Chapel.

This is a spring well of good water. It is on the face of a green hill, and at it grew a thorn bush from which it was denominated.

Corrig Leagh -- Inhabitants 26

Carraig Liath, the grey rock.

The Grey Rock (Eng.) -- Inhabitants

Carrickleagh -- J. O'D.

Situated in Knockderk Td. and within 1 chain of the E. boundary.

This rock, which is almost round, is about 12 feet in diameter. It is limestone, and is placed in a valley.

Barna (Village of). -- Inhabitants 27

Bearna, a gap.

Barna -- J. O'D.

Barna (contd.)

Situated on the junction of the Tds. of Treanmanagh, Plaukarauka, Ballynaclogh and Gortnacoolagh, also at the crossing at right angles of the two roads from Pallas Grean to Oola and from Newpallas to Emly &c.

This village contains about 20 houses, all of mud. Two are licensed public houses. It is placed on rising ground.

Keating's Well -- Inhabitants 28

Tobar a' Cheitinigh, Keating's well.

Keating's Well -- J. O'D.

Situated in the S. corner of Kilduff Td.

This well is about 3 feet wide, of good spring water, and has a small rivulet flowing from it. It is situated in a green field.

Pallas Grean (Village) -- Inhabitants 29

Sráid na Pailise, the street of Pallas

Pallas Grean -- J. O'D.

Pallas -- Barony Map

Pallis Grean -- County Map

This village is situated on the union of the Tds. of Pallas, Moymore, Pallas Hill and Sunglen, and on the road from Kiltteely, &c., to Doon and Cappamore.

It contains about 40 houses, chiefly of mud construction and low, except J. Apjohn's which is 2 story high. Three of the houses are licensed public houses. It has 4 yearly fairs, and a market one day preceeding each fair, to which nothing is brought except pigs, the only stock in demand even at the fairs. In the W. end of this village is the ruin of the Established Church, in being until 1839 when the roof was taken of it to permit it undergo repair. But it is considered that a new Church will be erected in Newpallas, and this ruinous one condemned.

Nicker Chapel -- Inhabitants 30

See townland name. J. O'D.

Situated in the centre of the S. end of Nicker Td., 2 chains S. of the road from Pallas to Caherconlish.

This Chapel was built in 1833 at the expense of £700 by the parishioners. It is a small neat building in the form of a cross, and is capable of containing about 1,000 persons.

Kilduff Castle -- Inhabitants 31

See townland name. J. O'D.

Situated in the centre of the N. part of Kilduff Td., and S. of the road from Limerick to Tipperary.

Of the origin and of the inmates of the castle there is no account by the inhabitants. It is about 70 feet high to the top of the chimney, and only one half is standing; the other half has fallen to the ground. It is about 12 feet wide.

The Moat of Pallas -- Inhabitants 32

Móta na Pailise.

Moat of Pallas -- J. O'D.

Moat -- Barony Map

Situated in the N.E. corner of Cloghaderreen Td.

This moat or fort, which is circular, is one chain in diameter. The top of the moat is green and flat, and the sides gradually widen to the base, which is about 40 feet from the summit. It is composed of earth, and the inhabitants of the district, in digging about it, find small bones, etc., mixed with the earth.

Rath Cree 33

Not known to the people by this name.

Ballinacree is the name of a townland in the adjoining parish of Latten Co. Tipperary.

Situated at the middle of the E. boundary of the Td. of Longstone.

This fort, which is circular, is about 2 chains in diameter, and 5 feet high. It is composed of earth, and around it grow some hawthorn bushes. Its centre, instead of being flat as is usual, is concave, in depth about 6 feet, from which cause it is called Rathcree, or the "Heart Fort".
