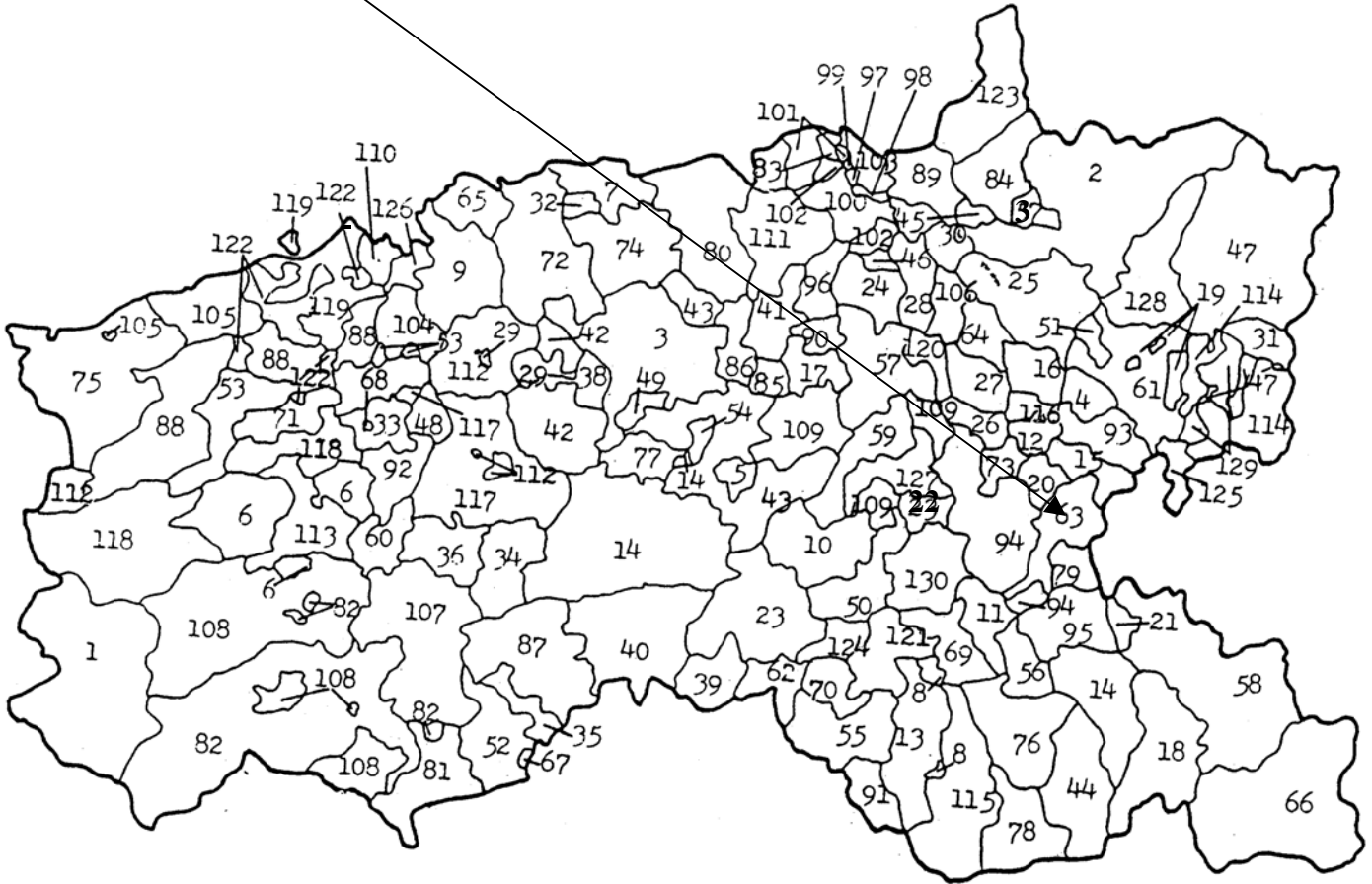

This Parish contains 3,999 acres, st. measure. It is bounded on the N. by Ballinlough Ph.; W. by the Phs. of Ballynamona and Knockainy; S. by the Phs. of Athneasy, Knockainy, Knocklong and Kilfrush; and E. by the County of Tipperary. It lies on the eastern margin of the County, and consists, for the most part, of good land.

According to Archdall, a commandery for Knights Hospitaliers was founded here in the reign of King John, and from this circumstance the parish takes its name.

This townland is situated in the S.E. extremity of the parish. It is bounded on the N. by Knockainy Ph. and the Td. of Gotoon; E. by the Ph. of Kilfrush; S. by the Phs. of Knockainy and Knocklong; and W. by the Ph. of Knockainy and the Td. of Newtown.

It is the property of Lord Kenmare, Killarney, and contains 597 acres of arable land.

It is the property of Lord Kenmare, Killarney, and contains 99 acres, about $\frac{2}{3}$ of which is a demesne, and the remainder arable land. In the West of this td. is the Village of Hospital. There is also the ruin of an Abbey.

In the W. extremity of the parish. Bounded on the N. by Lodge Td. and the Ph. of Ballynamona; W. by Ballynamona Ph.; S. by the Tds. of Millfarm and Barrysfarm; and E. by the Tds. of Lodge, Oldtown Ryan and Oldtown Bennett.

It is the property of Lord Kenmare, Killarney, and contains 599 acres, made up of about 36 acres of rough pasture, about 80 acres of demesne, and the remainder arable land. Near the W. boundary is Castlefarm House. In the N. of the td. is Barnameena Fort. In the S. of the td. is a Trigl. Station, called Hospital Hill.

The property of Lord Kenmare, Killarney, and contains 454 acres of arable land. About the N. central part of the townland is a fort.

The property of Lord Kenmare, Killarney, containing 543 $\frac{1}{2}$ acres of arable land. In the S. of this townland is a fort, and near the W. boundary is Lodge Hall.

In the E. extremity of the parish. Bounded on the N. by the Td. of Oldtown Ryan; W. by Castlefarm and Barrysfarm Tds.; S. by Coolalough Td. and the Ph. of Emly; and E. by Emly Ph.

The property of Lord Kenmare, Killarney, containing 541 $\frac{1}{2}$ acres of arable land. In the S. of this td. is a fort. There is also a Trigl. Station, called Oldtown. On the W. boundary is Ahnageeragh Bridge, and on the E. boundary is Ballynaveen Bridge.

Kenmare Castle -- J. O'D.

In the northern part of Barrysfarm Td., and within $\frac{1}{2}$ chain of a river.

The ancient commandery for Knights Hospitallers and its possession were granted by Queen Elizabeth to Sir Valentine Brown, who erected a splendid castle on, and probably out of, the ruins of the Commandery. His descendants became Earls of Kenmare, and consequently the castle came to be called Kenmare Castle. It, too, is now in ruins.

Abbey Ruins & Grave Yard -- Local 19

In the Townland of Barrysfarm.

The church of the ancient Commandery. Only its walls now remain; and, in a niche on the N. side of the high altar, is the tomb of a knight, which is said to be the tomb of the founder.

River Mahore -- Plan 20

It is the boundary between the Tds. of Castlefarm and Barrysfarm.
