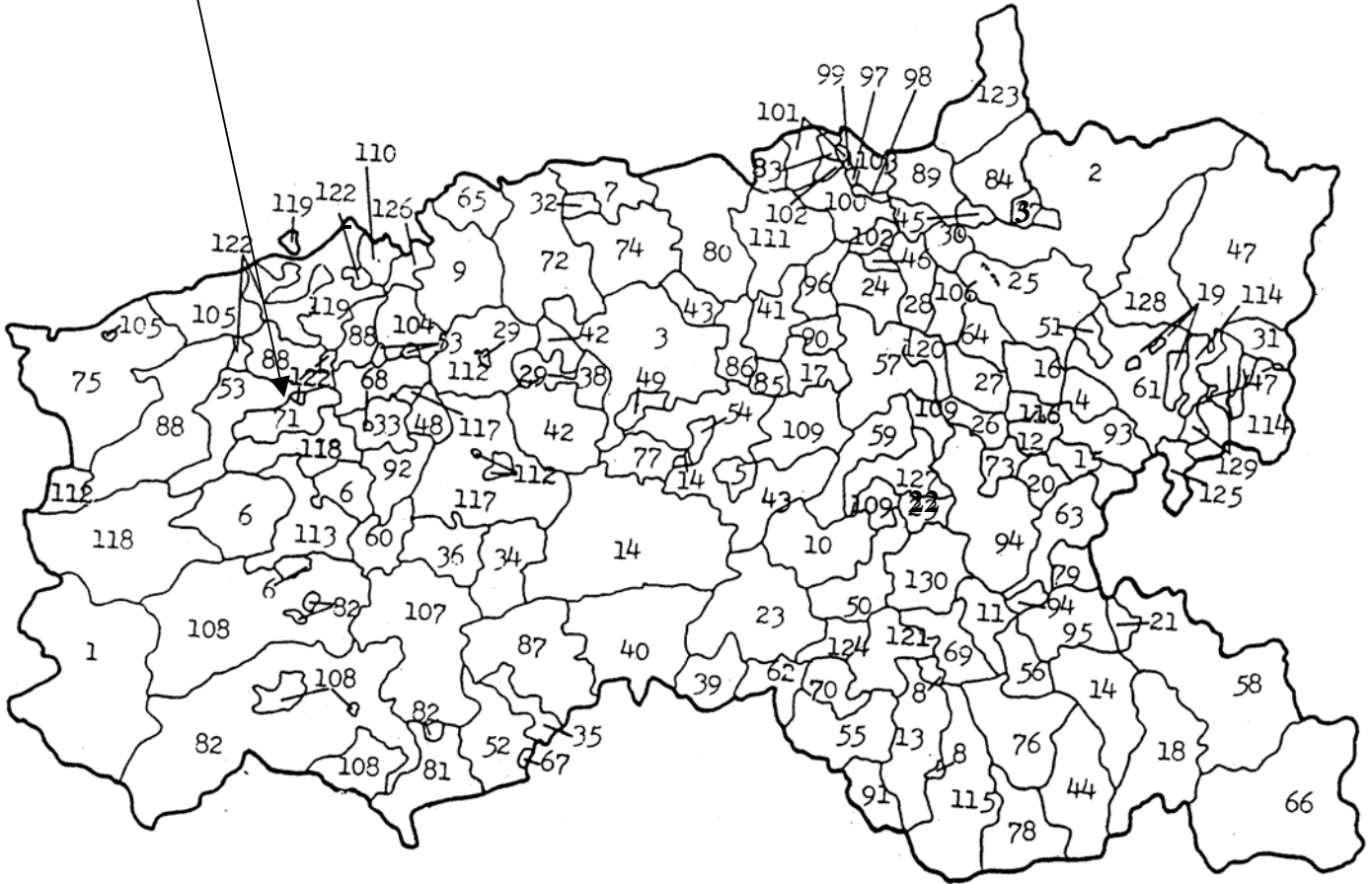

A central parish in the Barony of Shanid, containing 2,762 acres, st. measure. Bounded on the N. and W. by Dunmoylan Ph. and by part of Shanagolden Ph.; E. by the Ph. of Kilbradran; and S. by the (2nd Division of the) Ph. of Rathronan.

This parish contains no Protestants and 410 Catholics, according to the information procured from the Revd. Michl. O'Halloran, P.P., who resides in the Td. of Coolcappagh, in Kilbradran Ph. The crops generally sown are oats, potatoes and some wheat. The corn is generally carried to Rathkeale for sale, where it is bought and carried to Limerick for exportation. The soil to the West is in general bad, immense moors with heathy and spungy arable; but the eastern part is good. Lime is much used for manure and is generally brought from Askeaton. Wages of farm servants:- Males £4, Females £2, with board per annum; Labourers 8d. per day in summer and 6d. per day in winter.

A central townland, containing 141½ acres. Bounded on the N. by Dunmoylan Ph.; W. by Shanagolden Ph. and the Td. of Boughilbo; S. by Grouse Lodge Td.; and E. by the Td. of Kilcolman.

The property of the Revd. Edwd. Conyers, Knockaun Glebe, 7 miles west of Killarney. Agent, Mr. Denis Noonan, Grouse

Lodge. Held under lease; rent bulked £160 per annum; held in one farm, except $\frac{1}{2}$ acre. Co. Cess 2s.2d. per acre $\frac{1}{2}$ yearly. All good soil, mostly in meadow and producing a very good crop of hay.

The proprietor is the Revd. Edwd. Conyers, Knockaun Glebe, 7 miles west of Killarney. Agent, Mr. Denis Noonan, Grouse Lodge. Held under lease; rent bulked, averaging 26s. per acre for arable. Farms from 20 to 71 acres. Co. Cess 2s.2d. paid for each of 20 acres $\frac{1}{2}$ yearly. Soil coarse, moory and shallow surface. Poor crops. Rents all bulked at £270 per annum.

In the eastern extremity of the parish. Bounded on the N. by Dunmoylan Ph.; W. by Kilcolman Td.; S. by the Phs. of Rathronan and Kilbradran; and E. by Kilbradran Ph.

Proprietor the Earl of Clare, Mount Shannon, 4 miles E. of Limerick. Agent, Thomas Davinport, Esq., Ballynacourty, Kenry. Part held under lease, and part yearly. Rent from 36s. to 48s. per acre. Farms from 36 to 55 acres. Co. Cess 2s.2d. paid for each of 190 acres $\frac{1}{2}$ yearly. Soil middling, producing good crops of potatoes and oats, but bad wheat; good pasture.

A detached portion of the Ph. of Shanagolden, situated in the N. side of Kilcolman Ph. Bounded on the N. by Dunmoylan Ph.; W. By Dunmoylan Ph. and Boughilbo Td.; S. by Boughilbo Td.; and E. by the Td. of Ballydoorlis.

Contains 156 acres, and is the property of the Earl of Clare, Mount Shannon. Agent, Thomas Davinport, Esq. Held under lease; rent from 20s. to 42s. per acre. Farms from 7 to 21 acres. Co. Cess 2s.2d. paid for each of 100 acres $\frac{1}{2}$ yearly. Soil middling, producing middling crops of wheat, oats, potatoes and flax. There is some good pasture.

Glebe of Kilcoleman -- B.S.S. 5

This Glebe is situated in the interior of the south side of Kilcolman Td.

It is the property of the Established Church, and is held under lease by Michael Crogan, Moygin, Kilmoylan Ph. Rent bulked at £7 10s. per annum. Co. Cess paid for 2 acres half yearly. Soil - good pasture.

In the western extremity of the parish, and contains 997 acres. Bounded on the N. and W. by Dunmoylan Ph.; S. by Rathronan Ph.; and E. by Rathronan Ph. and the Td. of Boughilbo.

Proprietor William Richard Yielding, Esq., Bell View, Croom. Agent, David Fitzgerald, Esq., No. 109 Georges St., Limerick. Held under lease, and rents all bulked at £376 7s. 7d. per annum. Co. Cess 2s. 2d. for each of 148 acres $\frac{1}{2}$ yearly. Soil chiefly bog with a little moory spungy arable in the Glens.

In the S. side of the parish, and contains 363 $\frac{1}{2}$ acres. Bounded on the N. by Ballydoorlis Td.; W. by Boughilbo Td.; S. by Rathronan Ph.; and W. by the Td. of Knockbweeheen.

Proprietor Revd. Edwd. F. Conyers, Knockaun Glebe, 7 miles W. of Killarney. Agent, Denis Noonan, Grouse Lodge. Held under lease; rent bulked at £207 6s. 1. per annum, averaging 22s. 11d. for each arable acre. Co. Cess 2s.2d. paid for each of 20 acres, all in one farm. Soil not good, has a moory shallow surface, and produces poor crops of oats and potatoes. There is middling quality, coarse pasture.

In the E. side of the parish, and contains 137 acres. Bounded on the N. by Dunmoylan Ph.; W. by Ballydoorlis Td.; S. by Knockbweeheen Td. and Rathronan Ph.; and E. by the Td. of Carrons.

Proprietor the Earl of Clare, Mount Shannon. Agent, Thomas Davinport, Esq. All held under lease and part sublet. Rent from 26s. to 45s. per acre. Farms from 22 to 58 acres. There are two cottiers, one of whom has one acre at £4 per annum. Co. Cess 3s.4d. paid $\frac{1}{2}$ yearly for each of 80 acres.

In the E. side of the parish. Bounded on the N. by Kilcofman Td.; W. by the Td. of Grouse Lodge; and S. and E. by the Ph. of Rathronan. Contains 301 acres.

Proprietor the Earl of Clare. Agent, Thomas Davinport, Esq. Held under lease and sublet to tenants. Rent from 30s. to £4 per acre. Farms from 1 to 20 acres. Co. Cess 2s.2d. paid $\frac{1}{2}$ yearly for each of 30 acres. Soil coarse heathy, but is now for the most part reclaimed.
