It is from 3 to 4 miles long and about the same in width. It contains 4,435 acres, of which 1,916 are in the Barony of Clanwilliam; the remaining 2,519 acres are in the County of the City of Limerick. It is a well cultivated parish. The road from Limerick to Dublin forms part of its northern boundary.

Barrington's Bridge

This is a metal bridge built by Barrington at his own expense; but he charged passengers across it until he had back the money he expended on it. It is 57 feet long and 10 feet broad, with one arch in or about 10 ft. high.

It is a circular, enclosed, cultivated garden, said

to be inhabited by fairies. These latter are said to appear at night and engage in sports and games. They do not harm anyone or anything, but are regarded as good neighbours.

This house is now being repaired at the expense of Sir Richard De Burgh. It is handsomely built, is about 2 stories high, 60 ft. long and 50 ft. broad, and is seated in a backward part of the demesne surrounded by trees.

Biddyford Chapel

Situated in the N. end of Biddyford Td., and about 3 chains E. of the cross-roads at Ahane Chapel.

This chapel was built in 1837 by public subscription. It is 2 story high, and about 84 ft. long and 30 ft. broad.

Biddyford Dispensary

Situated in the N.W. end of Biddyford Td. and joins the road at the W. side of Biddyford Chapel.

This house was first intended for a factory. It is said to have been built in 1825 by the Government, and then given to Sir Richard De Burgh. He, in turn, has given it for a dispensary.

It was once a Roman Catholic Chapel, according to the inhabitants, but is now a ruin. The walls are about 30 ft. long, 20 ft. broad, and 10 ft. high. Attached to the ruined church is a burial ground, about 150 ft. square, with a large decayed tree about 3 feet south of the ruins, which are seated on a small eminence overlooking the river of Killingarriff.

Killinagarriff Bridge -- Local

Situated in the centre of the Killinagarriff Td., and on the road leading from Ahane Chapel to Abington.

This bridge is said to have been built about 150 years ago. It is 2 chains long with 5 arches about 10 feet high.
