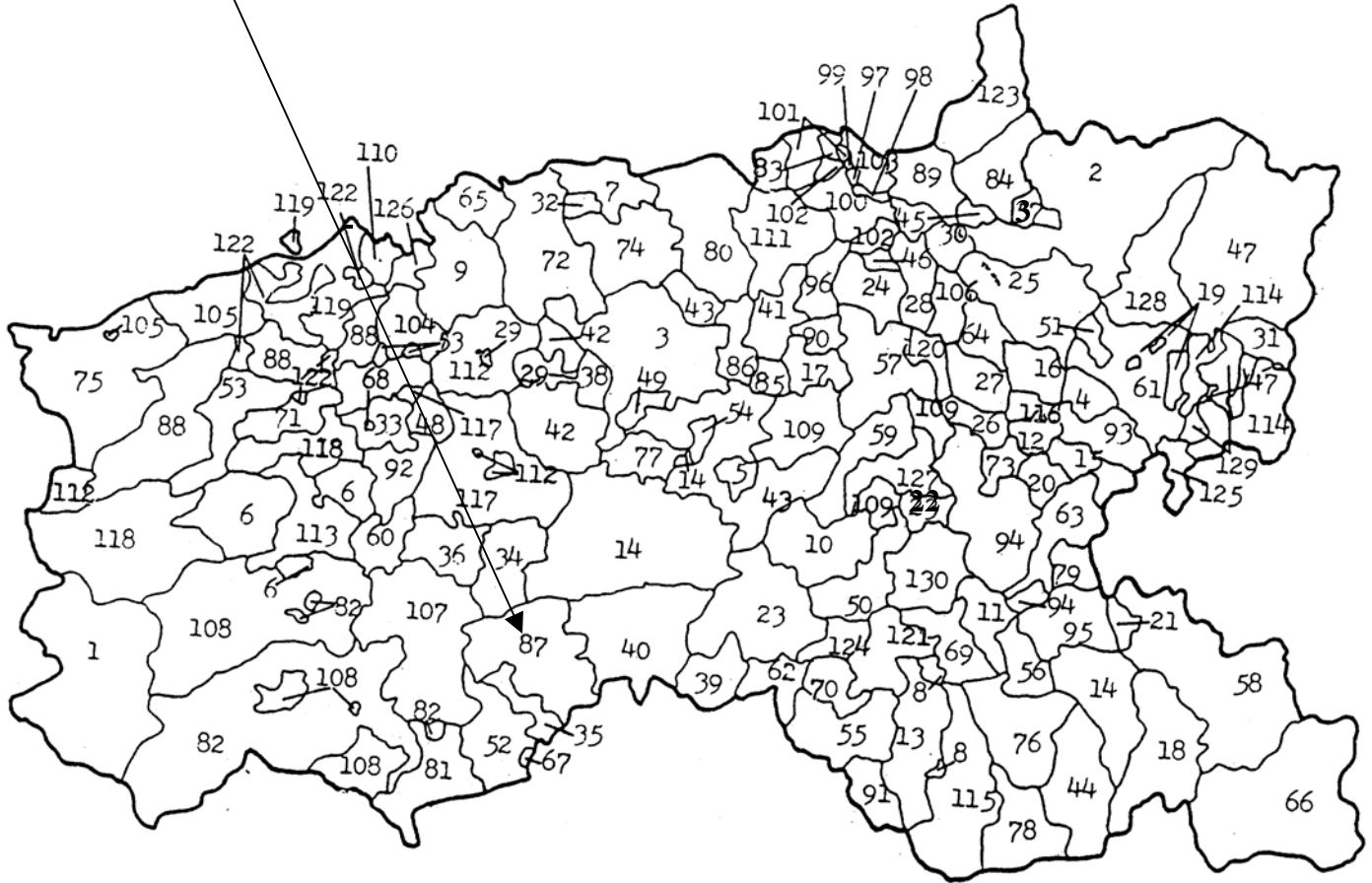

N.B. In the Civil Survey of 1654-56 this parish is included under 'Parishes of Corkamohyde and Cloinecreave'.

Kilmeedy Parish is about 9 statute miles S. of Rathkeale. It is bounded on the S. by the Co. Cork and Cloncrew Ph.; W. by the Phs. of Drumcullaheer and Mahoonagh; N. by the Phs. of Mahoonagh, Cloncagh and Ballingarry; and E. by Ballingarry and Castletown Phs.

The parish is the property of the several individuals mentioned in the description given of each townland. It consists principally of arable land, with a portion of mountain pasture along its N. boundary and a few patches of bog interspersed through it. It contains two small towns or villages, viz. Feenagh and Kilmeedy, together with several Gentlemen's mansions. The road from Rathkeale to Kilmeedy, and the road from Kilmeedy to Drumcullaheer, together with several bye-roads run through the parish.
