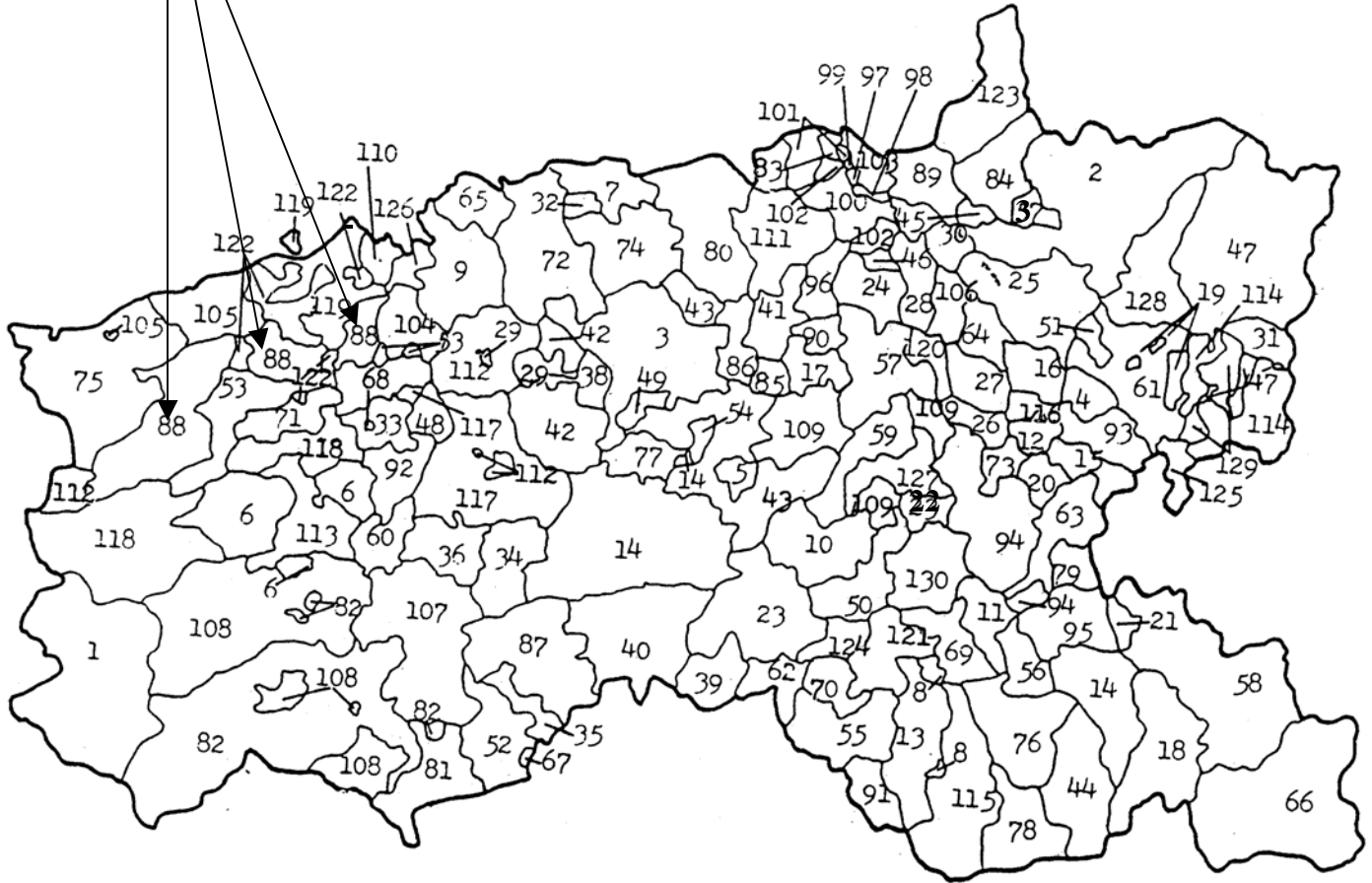

A central parish in the Barony of Shanid. Bounded on the N. by the phs. of Kilfergus, Loughill and Shanagolden; E. by the phs. of Shanagolden and Dunmoylan; S. by Rathronan Ph., 1st Division; and W. by a detached portion of Nantinan Ph. and by Kilfergus Ph. Contains 15,091 statute acres.

In this parish there are 5 Protestants and 2,109 Roman Catholics, according to the information furnished by the Revd. Mortimer Collins, P.P., who resides in the td. of Kimeheer, Shannagolden, and by Hennessy, the Clerk of the Church. There is a field pointed out in the td. of Cloonlahard W. as having been the scene of a battle, at which is a stream called Ahanagorp (the Ford of the Bodies). In the western part of the parish, which is bad spewy soil, the crops generally sown are potatoes and oats; but the eastern part of the parish, at the very extremity, produces some wheat. The corn is generally sent to Limerick for sale, and from thence is exported. Lime is much used as manure, and is brought principally from Askeaton. Wages of farm servants:- Males, from £4 to £5 per annum; females £2 per annum, with board. Labourers:- 8 per day in summer, and 4d. to 6d. per day in winter.
