

The nearest part of this parish is distant 2 miles from the town of Newcastle and is in the south of Co. Limerick. It is bounded on the N. by the phs. of Orenge and Clonelty; E. by the phs. of Clonelty, Kilmeedy, Cloncagh and Drumcullaher; S. by the phs. of Drumcullaher, Killaghholehane and Kilmeedy; and W. by the phs. of Killmeedy and Monagay.

This parish contains 12,687 acres, and is in a state of high cultivation, having but very little bog and rough pasture interspersed through it. It contains a small village in the north of the parish, called Mahoonagh, and another in the south thereof, called Peahanagh. There are, also, a few Gentlemen's seats. The river Deel runs through it, as do also the road leading from Newcastle to Drumcullaher and six bye-roads abutting therefrom.
