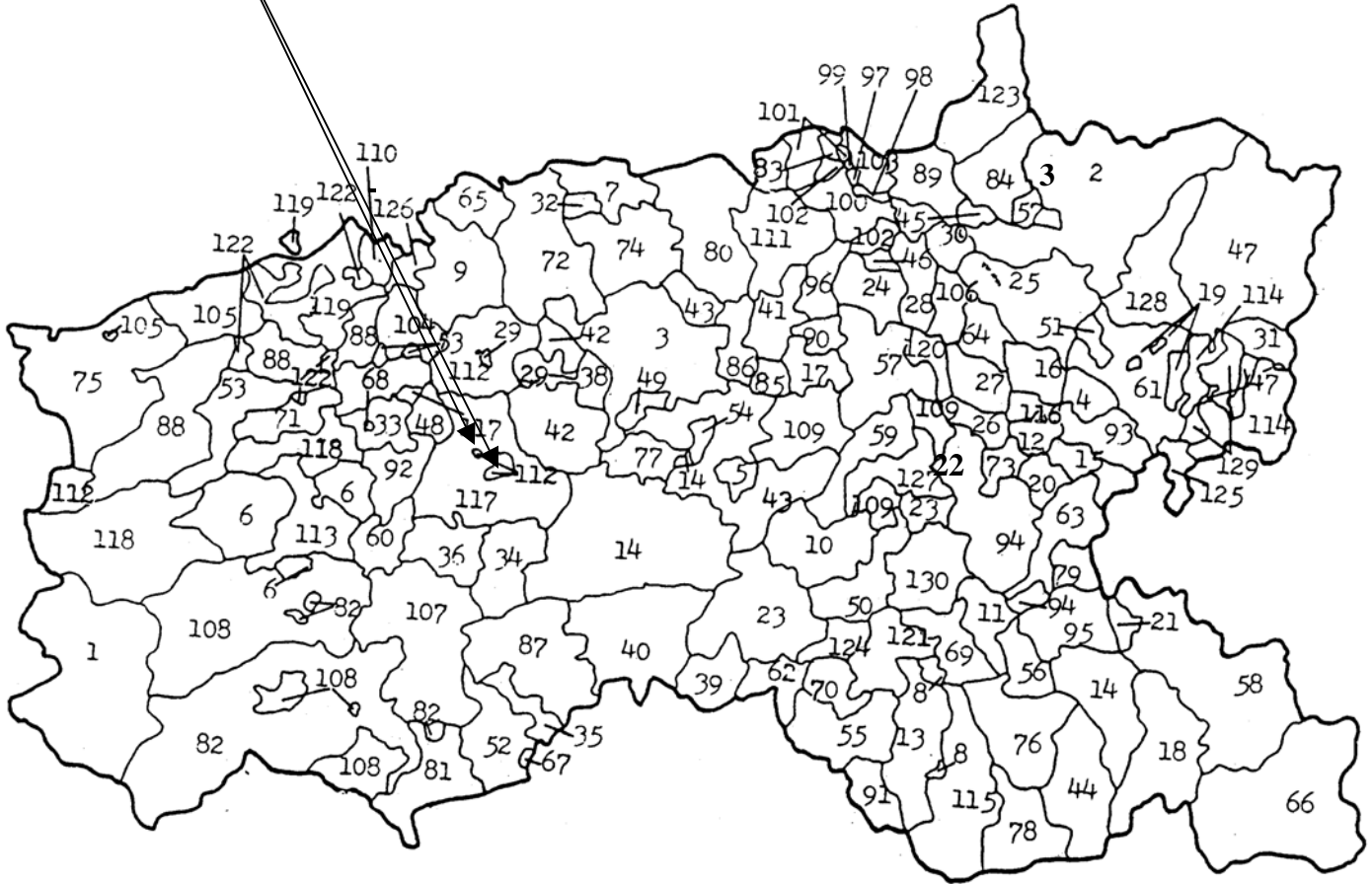

This parish is of a rectangular form. Its greatest length from N. to S. is 3 $\frac{1}{2}$ miles, and from N.E. to S.W. is 4 $\frac{1}{2}$ miles. It is bounded on the N. by Kilcornan and Askeaton Phs.; S. by Rathkealkeale Ph.; E. by the phs. of Croagh and Cappagh; and W. by the phs. of Lismakeery and Kilbradran.
