

Parish of Newcastle (contd.)

In Glenquin Barony, except the tds. of Kilrodane and Gortnaglogh which are in Shanid Barony. Bounded on the E. by the phs. of Ardagh and Grange; S. by Monagay Ph. and a detached portion of Ardagh Ph.; W. by part of Ardagh Ph.; and N. by Rathronan Ph. It contains 5,425 statute acres.

This is a well cultivated parish. The village of Newcastle is in its southern extremity; its public buildings are a Court House, a Military Barrack, an old and a new Church, a Roman Catholic Chapel, and a Fever Hospital. The two latter are in the part of the town south of the River Arra and in Monagay parish. The Castle, which probably gave name to the village and parish, is in the western part of the village, on the north bank of the river Arra.
