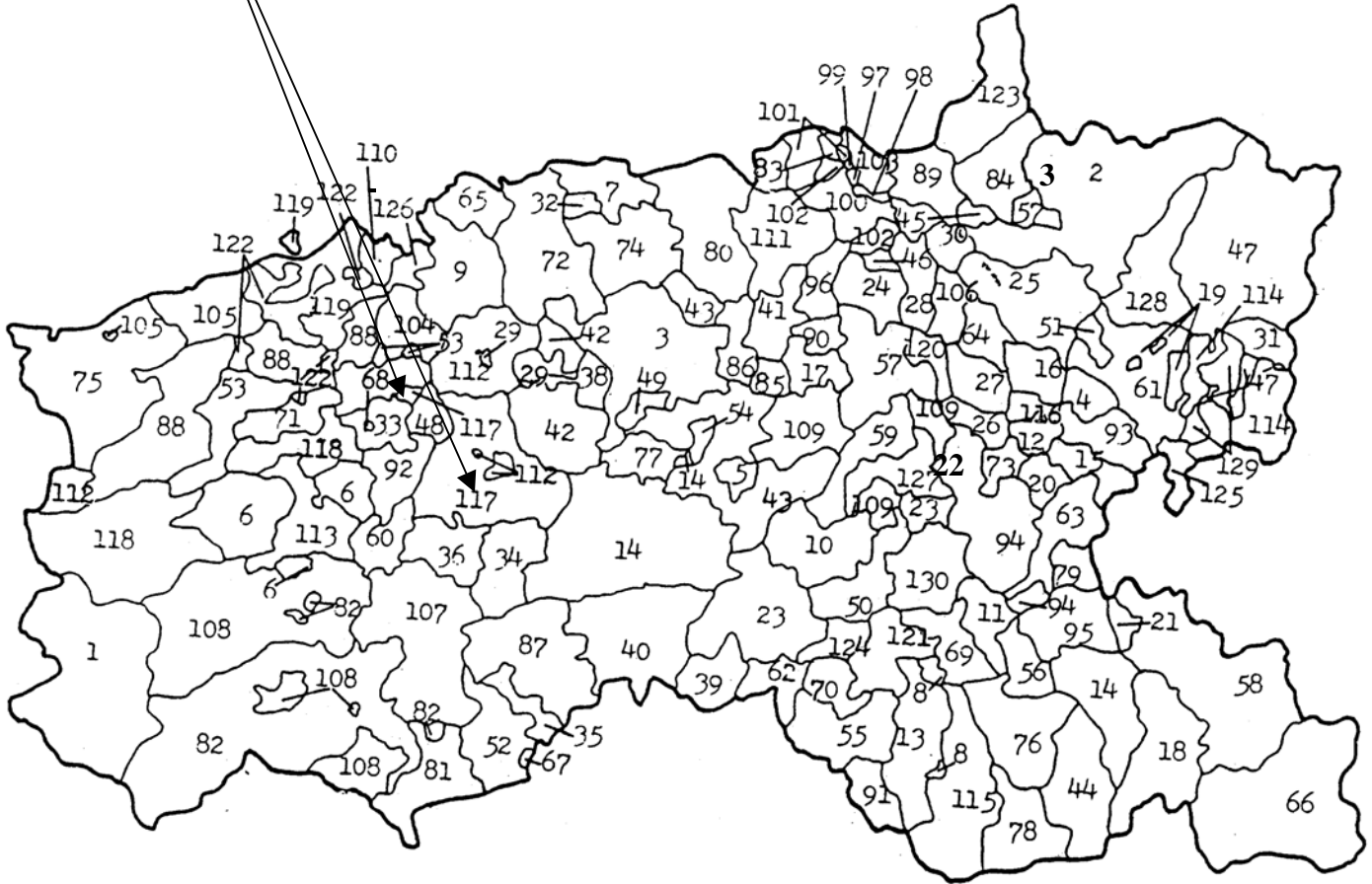

This parish is situated about 14 miles S.W. of the City of Limerick. It is bounded on the N. by Nantenan and Cappagh phs.; E. by Croagh and Ballingarry phs.; S. by Cloncagh and Clonelty phs.; and W. by the phs. of Grange, Kilsannel and Doondonnell. It contains 12,095 acres, statute measure, including a detached portion of 322½ acres and 33 acres of water.

In this parish is situated the town of Rathkeale, from which the parish derives its name. This parish contains about 5,000 inhabitants, one church and one R. C. chapel, about 14 public houses and as many woollen drapers, &c. The parish for the most part is in a high state of cultivation, but has a scarcity of fuel. There is one extensive flour mill, the property of J. S. Browne, Esq., and there is an insignificant corn mill nearly in ruins.

On the S.E. side of the parish and contains part of the town of Rathkeale. Bounded on the N. by Wolfesburgess E.; W. by English Tenements; S. by Ballywilliam North; and E. by Beechmount Demesne. Contains 105 acres.
