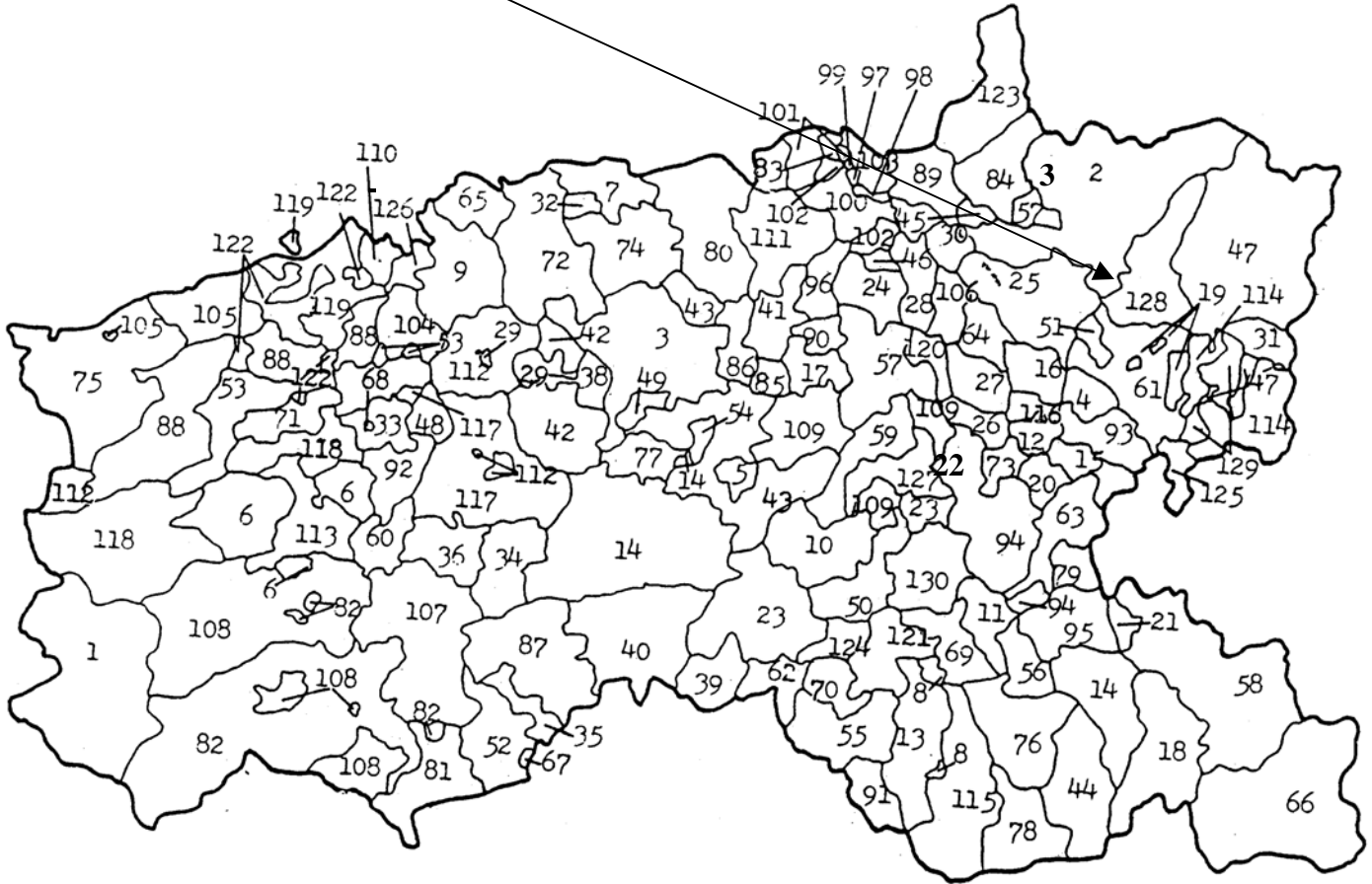

Situated about 12 miles E. of the City of Limerick. It is bounded on the E. by the Ph. of Doon; N. and W. by Abington Ph.; and S. by the Ph. of Green.

This parish is about 6 miles long, and is 3 ft. broad at one end and at the other end terminates in a point. It is very hilly and chiefly arable. It is well supplied with roads, the principal of which is that leading from Limerick to Cappamore through its centre; another road leads S. from Cappamore to Caheroonlish, and a third in its northern point leads from Murroe to Doon Village.

This td. contains 235 acres, which are arable and without limestone; but the chief part of it is liable to floods. Soil deep, producing potatoes, corn and some flax. The proprietor Stafford O'Brien, Esq. has it let by a lease for ever to Capt. Thos. Lloyd, and he again per his agent Hugh B. Bradshaw, Esq., to six

This td. contains 322 acres, of which about  $\frac{1}{2}$  is bog, the rest arable, without limestone. Soil very light, producing potatoes, corn and flax. The proprietor Stafford O'Brien, Esq. has it let by a lease for ever to Sir Richd. De Burgh, Bart., and he again per his agent Joseph Walplate, Esq. to 2 tenants by leases expiring in 1842 at £2 12s. to £1 per acre. Tithe included in rent. Co. Cess generally 1s.2d. to 1s.8d. per acre half yearly. Bog used for fuel is in abundance, but bought by the tenantry. The prevailing names are Malleys.

Cess generally 1s.4d. to 1s.8d. per acre half yearly, and tithe 2s. to 1s.6d. per acre. Bog in abundance. Prevailing Names: Blackwell.

Situated in the west end of the parish. Is bounded on the E. by the Td. of Turagh; W. by the Ph. of Abington; N. by Portnard Td.; and S. by the td. of Tough or Towerhill.

This td. contains 851 acres, of which about  $\frac{1}{2}$  are bog, the rest arable without limestone. Soil partly deep and wet, producing potatoes, corn and flax, with some wheat. The proprietor Stafford O'Brien, Esq., has it let by a lease for ever (including Drumcloher and Drumalta) for £138 gross to Sir Rich. De Burgh, and he again per his agent J. Walplate, Esq., to 48 tenants, some by leases expiring in 1842 and the rest at will, in farms of 35 to 1 an acre, at £2 10s. to £1 5s. per acre. Co. Cess 1s.4d. to 1s.8d. per acre half yearly. Tithe 1s.6d. per acre. Bog for fuel is in abundance.

This td. contains 736 acres, of which about 20 are rough pasture and the rest arable with limestone. Soil partly deep, producing potatoes, corn, flax and some wheat. The proprietor Stafford O'Brien, Esq. has it let by a lease for ever to Sir John Ribton, and he again per his agent Mr. Richd. Wheeler to 32 tenants by leases of 3 lives, in farms of 70 to 12 acres, at £3 to £1 5s. per acre. Co. Cess generally 1s.2d. to 1s.8d. per acre half yearly, and Tithe 1s.6d. per acre. Bog very scarce. Situated in the N. end of the parish of Tuogh. Is bounded on the E. by the Ph. of Doon; W. by the Ph. of Abington; S. by the Td. of Portnard; and N. by the Phs. of Abington and Doon.

This td. contains 2,123 acres, of which about  $\frac{1}{3}$  is bog and rough pasture, the rest arable. Soil for the most part deep, with some limestone, and producing potatoes, corn and flax. The proprietor Stafford O'Brien, Esq. has it let by a lease for ever to Richard Lloyd, Esq., in whose own occupation half of it remains, and the remainder he has let to 48 tenants (besides about 30 more miserably poor tenants under the above, at will and at £1 10 per acre), chiefly with leases of one life and At £1 to £1 7s. per

Situated in the centre of the parish. Is bounded on the E. by Killuragh Td.; W. by Drumcluhur Td.; N. by Drumsallagh Td.; and S. by Drumalta Td.

This td. contains 733 acres, which are arable and with limestone. Soil partly deep, producing potatoes, corn, flax and some wheat. The proprietor Stafford O'Brien, Esq. has it let by a lease for ever to Wm. Lloyd, Esq., in whose own occupation about  $\frac{1}{2}$  of it remains, and the remainder is let by a lease of 2 lives or 21 years to 9 tenants in farms of 60 to 30 acres, and at £2 2s. per acre, tithe included. Co. Cess generally 1s.2d. to 1s.8d. per acre half yearly. Bog used for fuel is in abundance. Prevailing Names: Ryan.

Miscellaneous Features

Thobar Warinfola -- Inhabitants 12

Tobar Bhárra na Fodhla, the best well of Fodhla, i.e., Ireland.

Situated in the S.W. corner of Drumsallagh Td., and about 10 chains S. of the road from Limerick to Cappamore, and nearly the same distance E. of another road leading through Drumsallagh into Drumcluhur Td.

This is a well of pure spring water. It is placed in a green field, and is about 5 ft. in diameter.

Situated in the middle of the N. boundary of the td. of Tuogh, between same and Drumsallagh, on the road from Cappamore to Caherconlish and on Ahabwee River.

This is a small bridge, built in 1833. It is about 6 ft. long and 2 or 3 ft. high, with one small arch.

- The Yellow Ford River. See preceding name.
- Ahboy River -- J. O'D.
- Rises in the Td. of Turagh, runs west for about 1½ miles, forming the boundary of Drumsallagh from the tds. of Turagh and Drumcluger, and falls into Dhu Glasha.
- This is a small brook, about 3 ft. wide and very shallow, with a sandy bottom. It is without any fish.
- Kyle Weol (i.e., Cill Mhaol, } -- Inhabitants 15  
the blunt burial ground)
- Cill Mhóire, Maria's (Martha's Church).
- Kilmoria -- J. O'D.
- Situated in the W. extremity of the td. of Pallasbeg.
- This is a small burial place, about one chain in diameter, and is chiefly used for the interment of children. It is in an orchard, and in the north corner thereof.
- Crann Harry -- Inhabitants 16
- i.e., Harry's Tree.
- Cranharry -- J. O'D.
- Situated in the td. of Pallasbeg, and nearly on the middle of the N. boundary.
- This is a large ash tree, growing on the summit of a hill. The derivation of the name is as follows. About the year 1800 Harry Ryan, a native of the district and a highwayman, commanded a company of accomplices, who, after the commission of an atrocious crime, dreaded its discovery through their commander. Whereupon they called a meeting on a certain night at the ash tree, and there they killed Ryan, and dragged his body westwards to a bog, where they buried it. There it remained until 1835, when the remains were recovered and reinterred in Doon Graveyard. The tree under which he was murdered has since been called Crann Harry, or Harry Ryan's Tree.
- Cappamore Village -- Inhabitants 17
- Ceapa Mór, the great plot (of ground).
- Cappamore -- J. O'D.
- Situated in the N. end of the td. of Turagh.
- This village contains about 80 houses, the greater

number being poorly constructed and of mud. Five are two story high; 6 are licensed public houses, and 14 with petty groceries. It contains a Roman Catholic Chapel, a Police Barrack and a Post Office, now intended; with quarterly fairs besides four more now in contemplation. The Chapel, which is placed in the west end of the Village, was built in 1836 by the parishioners at the expense of about £750, with the intended addition of £300 more to finish it. It is capable of containing 2,000 persons. There is also a National School in formation in the Village besides another in the interior of the parish, no schools being at present (1839) therein.

Situated in the S.E. corner of Tuogh Td., about 10 chains S. of Towerhill House, and about 10 chains N. of the road through Tuogh Td.

This well is dedicated to St. Bridget and devotions are performed at it, chiefly on the anniversary of the saint, i.e., the 1st. of February, on which day a pattern used to be held; but this has been discontinued on account of some impropriety that took place at the last pattern. The well has dried up since, moving nearly  $\frac{1}{2}$  mile further south, according to the natives, and leaving the original site a bare rock, having 9 remarkable holes in it, each about 6 inches in diameter, and having two very large ancient ash trees growing over it. At this old site homage is still paid.

This is the ruin of a Friary, part of the walls being about 15 feet high and overgrown with ivy. Around the ruins is a spacious and ancient graveyard, enclosed by a wall.

The seat of Wm. Lloyd, Esq. This house was built about the year 1800 at the expense of about £1,500. It is 3 story high and seated on an eminence. On its site, prior to its erection, were three towers, and it is from these towers that it has received its name.
