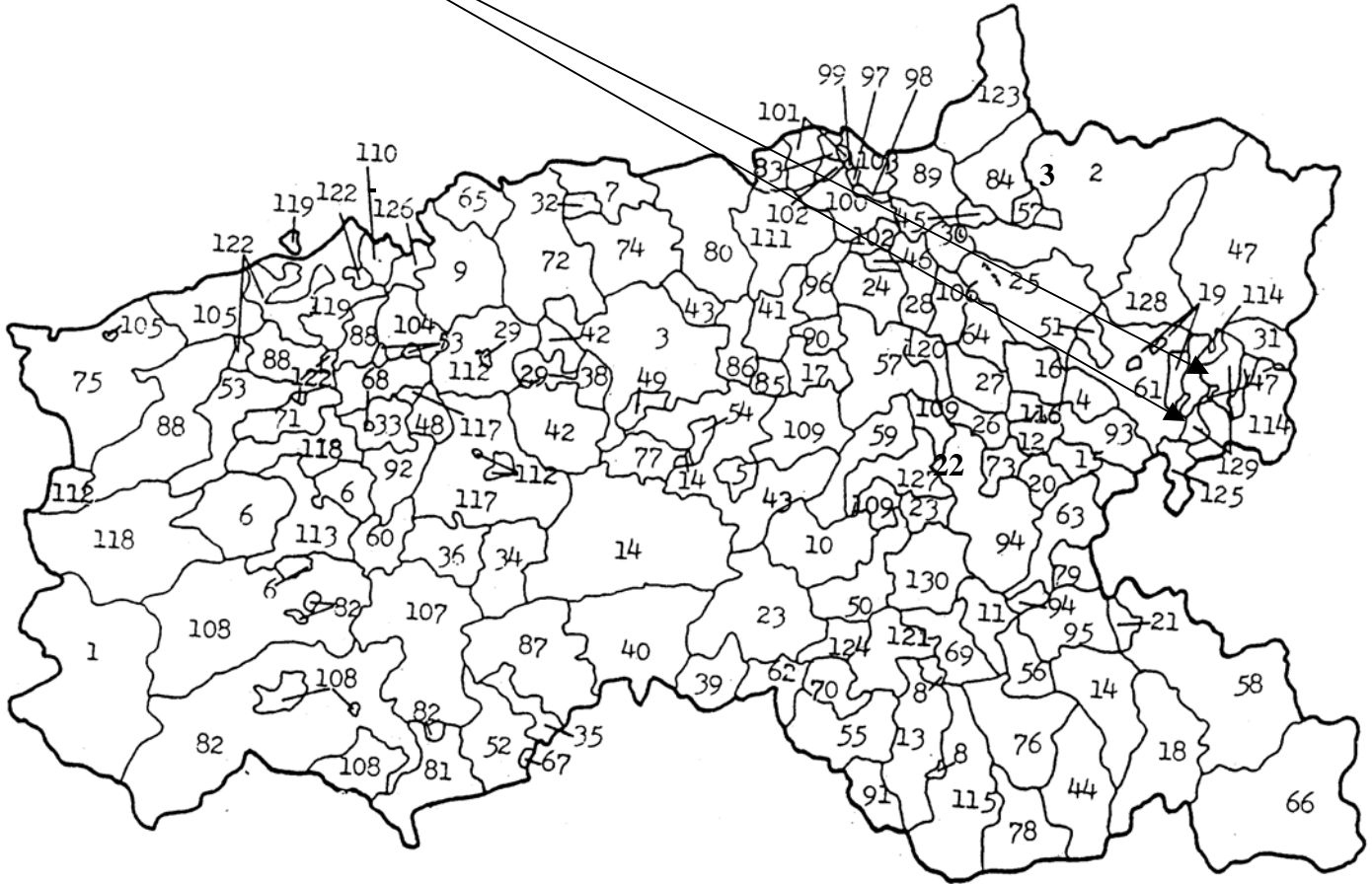

This parish is situated about 10 miles S.E. of the City of Limerick. It is in 2 parts. The first part is bounded on the S., E. and N. by the Ph. of Doon and on the W. by the Ph. of Cola. The second part, which is about one half mile south of the first, is bounded on the E. by Cola Ph.; N. by Doon Ph.; W. by the Ph. of Pallas Green; and S. by Templebredon Ph.

The first of these portions is about $1\frac{1}{2}$ miles long and 1 mile broad, containing 9 townlands, which are very level and in great part liable to inundations by the Dead River. The second part is about $1\frac{1}{2}$ miles long and $\frac{1}{2}$ mile broad, containing 5 townlands also level and good. The roads leading through it are the same as those of Cola Ph., which see.

Situated in the west end of an isolated portion of the parish. Is bounded on the E. and N. by Newtown Td.; W. by Cola Ph.; and S. by Treanmanagh Td. and the Ph. of Green.

This td. contains 26 acres, which are arable and with some limestone. Soil deep, producing potatoes, corn, wheat and flax. The proprietor has it let by a lease of one life at £4 per acre. Co. Cess generally 1s.4d. to 1s.8d. per acre half yearly, and Tithe not paid since 1834.

Situated in the east end of the parish. Is bounded on the E. by the Td. of Garryfrask, and on the W., S. and N. by Cola Ph.

This td. contains 353 acres, which are arable and without limestone. Soil partly light, producing potatoes, corn and flax. The proprietors Minor O'Ryan (per his agent Saml. Jellico, Esq., of Cahir) and Thomas Lloyd, Esq. have it let to 8 tenants, 2 by leases of lives renewable for ever and 6 by leases of 1 life or 31 years, at £2 10s. to £2 per acre, and in farms of 50 to 12 acres. Besides the above tenants, there are 8 very poor householders. Co. Cess generally 1s.4d. to 1s.8d. per acre half yearly. Tithe 2s. per acre. This td. contains 73 acres, which are arable and without limestone. Soil deep, producing potatoes, corn,

wheat and flax. The proprietor Riffernan Consadine, Esq. has it let to Jas. Scully, Esq. at £1 7s. 6d. per acre, in whose own occupation part of it is, and the remainder let to one tenant by a lease ending in 1850 at £4 4s. per acre, tithe included. Co. Cess generally 1s.4d. to 1s.8d. per acre half yearly.

The Moon Fort (Eng.) -- Inhabitants

Situated in the extreme south end of Cluggin Td., and also S. of the main road between Limerick and Tipperary.

This is a small fort, nearly level with the surface of the ground. It is about 1 chain in diameter, and is chiefly of earth tho' placed upon a limestone foundation. The inhabitants say that it is "an airy or gentle place upon which and in the same field light has been frequently seen at night", from which it has been called Ráth na Gealaighe, the Fort of the Moon.

The Ox's Fort (Eng.) -- Inhabitants

Situated in the centre of the east part of Newtown Td. and S. of the road from Cola to Pallas Green; also E. of another road running off same to the td. of Ballyneety, &c.

This fort, which is circular, is about 2 chains in diameter and 4 ft. high. It is composed of earth, with a beautiful green and level surface, and is surrounded with some hawthorn bushes. It is placed on the face of a green eminence, and commands a view over a great tract of country.

Cluggin Church -- Inhabitants 18

Situated in the S.E. part of the Glebe of Cluggin.

Although this is called a Church, it is really a grave-

yard, without any remains of a church in it. The graveyard is about 5 chains in length, about 4 chains in width, and enclosed by a stone wall about 4 ft. high. Internments are very rare in it at present, and it seems to be going out of use.

Thobar na Cruaghlee -- Inhabitants 19

Tobernacrahaneve -- J. O'D.

Situated in the td. of Cluggin, within 3 chains of the middle of the west boundary and about 10 chains E. of the road and Cluggin Church.

This well, which is placed in a cultivated field, is spring, and is esteemed for the goodness of its water. It is about 3 ft. wide, with a small rivulet flowing from it.

Thobar na Dhíhe -- Inhabitants 20

Tobernadiha -- J. O'D.

Situated in the S.W. corner of the td. of Cross, and south of the old road leading through same td.

This well is 2 ft. wide, is pure good spring, and is placed in a green field.

Cross Mills -- Inhabitants 21

Situated in the W. part of the td. of Cross, and north of the old road leading through same td.

These mills, two in number, are about 12 ft. distant from one another. One, a tuck mill, is about 14ft. by 12 ft. The other, used for carding and combing wool, is 30 ft. by 20 ft. Both are thatched.
