This parish is situated about 10 miles S.E. of the City of Limerick. It is in 2 parts. The first part is bounded on the S., E. and N. by the Ph. of Doon and on the W. by the Ph. of Cola. The second part, which is about one half mile south of the first, is bounded on the E. by Oola Ph.; N. by Doon Ph.; W. by the Ph. of Pallas Grean; and S. by Templebredon Ph.

The first of these portions is about 12 miles long and 1 mile broad, containing 9 townlands, which are very level and in great part liable to inundations by the Dead River. The second part is about 12 miles long and 2 mile broad, containing 5 townlands also level and good. The roads leading through it are the same as those of Oola Ph., which see.

This fort, which is circular, is about 2 chains in diameter and 4 ft high. It is composed of earth, with a beautiful green and level surface, and is surrounded with some hearthorn bushes. It is placed on the face of a green eminence, and commands a view over a great tract of country.

yard, without any remains of a church in it. The graveyard is about 5 chains in length, about 4 chains in width, and enclosed by a stone wall about 4 ft. high. Internments are very rare in it at present, and it seems to be going out of use.
