

POSTSCRIPT.

LONDON, SEPTEMBER 17.
 The journal of the Spanish operations contained in the French gazette, brought in so far as the 25th of August, a date later seven days than that on which it was on Friday last reported to have surrendered, by which it appears this is so much from the truth, that the Spaniards are less sanguine in their expectations of reducing that important fortress.

It is with the greatest pleasure we inform our readers, that an Officer arrived yesterday at Gibraltar, with dispatches from Governor Admiralty; these dispatches are dated the 2d inst. and contain the agreeable intelligence of the Governor having destroyed the Spanish muffle battery, that the Spaniards had been at so much expence in erecting, and that the garrison was in good health and spirits, and under the least apprehensions from the attack of the enemy.—By intelligence received from the Duke de Crillon entertained very sanguine hopes of success previous to the destruction of the battery, but since that period he has relaxed much in his firing, and it is supposed means will be used to raise the siege.

A second fleet of transports, with provisions for the latter end of next week. On Sunday Government received dispatches from Lord Howe, giving an account of his having cleared the Channel on Thursday at 10 o'clock, all well.

It was yesterday confidently asserted, that the Court of Madrid had sent a remonstrance to the Cabinet of Versailles, declaring that Spain was heartily sick of the war, and would be content to take share in it much longer, if tolerable terms of peace could be prepared from Great Britain. In consequence of this report, stocks rose considerably.

Letters from Paris of good authority assert, that the French Ministry are so divided, that several resignations and alterations are expected to take place.

The Rainbow and Recovery, which have sailed from Plymouth to join Lord Howe, our yesterday's letters from Portsmouth advise, that there is no least intention of attempting to weigh anchor, the vessel being found to stow, that several of her planks had started; which now appear to be the sole cause of her sinking.

A letter from Alexandria, that advice is received there from a great number of the inhabitants of that place, and raged there when the account came away, and therefore the letter advises not to suffer any vessel from thence, or from the adjacent sea, to enter Leghorn, for fear they should bring the pestilential disorder.

On Monday evening last, an express was sent from the Admiralty to the Arch Duke and Duke of Calabria, that the plague was the condition of the Duke of Calabria, being too far advanced in his progress.

The disagreement now subsisting between Denmark and Holland does not appear of sufficient magnitude to produce those serious consequences, which many people have pretended to predict. Denmark is too well acquainted with her own interests to suffer herself to be precipitated, by a slight event, into the engagement of war, which could not fail to deprive her of all those vast emoluments the now derives in the indiscriminate conveyance of the merchandize of the several Belligerent Powers.

The above observation is rightly founded, will be subscribed to, when it is considered, that Denmark has, for a time at least, relinquished the character of a martial people, and directed her whole attention to domestic improvement.— This wise conduct was the best means to rescue the Government from that state of imbecility and insecurity into which the nation had been plunged by an erroneous system of politics, and those terrible convulsions of state, which threatened to be followed by a revolution.

DUBLIN, Sept. 21.

Yesterday the Protestant Dissenters waited upon his Excellency the Lord Lieutenant with a congratulatory address, and were most graciously received.

It was yesterday very confidently asserted, that a neutral vessel was arrived at Waterford from Leghorn, which passed through the Straights the 25th ult. at which time the master declares, the Spanish flag was flying on the fortifications of Gibraltar.

Bradstreet, Recorder, who has ever the welfare of his country at heart, addressed his Excellency the Lord Lieutenant in a speech nervous, elegant, and spirited; suggesting how happy it was for Ireland to have a Chief Governor connected with and allied to men of the first families, and of known public virtue, patriotism and abilities; and not entertained a doubt but that his Excellency's conduct in his Government, would reflect the highest honour on his connections, by establishing the liberties of Ireland, on a firm and satisfactory base of security. His Excellency immediately replied, that it was on the absolute stipulation, that the most just, free, and liberal point of securing Ireland's commercial and constitutional rights were granted her, he undertook the Government of this Country; and for the attainment of which, he was determined to give his utmost attention.
