

Mr. Burke was vented by the House calling loudly for the question, which having been put, the motion was carried without a division, and the House adjourned.

Tuesday March 25.

The House went into a Committee on a Bill for reverting the Act of Attainder, passed in 1746, against Lord Ogilby, for restoring Daniel, commonly called Lord Ogilby, to his estate, and rendering him capable of enjoying any post under the Crown. Lord Newhaven was in the chair, and the Bill passed through the Committee without a debate.

Wednesday, March 26.

Lord Ludlow informed the House from the bar, "That his Lordship had waited upon his Majesty, with the Address of that Honourable House, which his Majesty had been pleased to receive most graciously; and that his Lordship had it in command to signify, that it was his Majesty's desire to do every thing in his power to comply with the wishes of his faithful Commons."

D U B L I N, April 1.

Extract of a letter from London, March 27. "Yesterday an officer was sent express from Gen. Conway, to Jersey, with instructions to the deputy Governor, to quell the mutiny that has broke out among the troops at that place, and which is said to have arisen from their infatuation on being immediately discharged."

It is a certain fact that France has not taken a single step towards disarming. Their politicians are under the greatest anxiety, lest we, in the scuffles of our parties, should have an opportunity of detaching America and Holland from her alliance, and then finding pretences for renewing the war. In which case they have no doubt of offering Gibraltar to the Spaniards to detach them from the alliance of the French.
