It is not merely the situation of Russia, that is a natural bar to her becoming a rival power in the marine line to England, France, or Holland, but that she has little commerce, and the genius of her subjects is so totally different from those of navigators.

The following short character of General Elliott, given by a young Portuguese, which we think very pretty in its kind, we have translated,—too good, discerning, and sensible, to abound with nice and subtle distinctions; a few general rules direct his heart; his whole view pointing to one great end, each of his minutest actions is determined by that specific view which ought, and which does, govern his mind. A noble sincerity appears in every part of his conduct; the more he is examined, the more he is approved; a great soldier, a good Christian, and a faithful subject.
