

**LAST NIGHT ARRIVED ONE  
BRITISH PACKET.  
AND THIS EVENING ANOTHER.**

Hague, May 30.

ORDERS have been dispatched provisionally to the Generals and Commanders of the regiments in the service of the Republic to hold themselves ready for marching on the first notice. The reason for this sudden change is not publickly known.

Utrecht, May 30. The late assurances of our difference with the Emperor being upon the point of being settled, have been succeeded by reports of war: These originated from accounts from the Hague, that on Wednesday last on the parade, orders were given to the Officers of the garrison to hold themselves in readiness to march at the first notice; this transition from pacific ideas to those of war are attributed to the contents of a memorial which the French Ambassador has lately delivered to the States General, the subject of which however is kept a profound secret.

Paris, May 23. Dr. Franklin, who is on the point of returning to his own country, is, it is said, to be appointed President of the Congress and to digest a new code of laws for regulating the interior police of the Republic, and prevent the disorders which arise in the cities for want of discipline.

L O N D O N, June 6, & 7.

Yesterday there was a private cabinet held of his Majesty's Ministers, at the house of Mr. Dundas, at Wimbledon, relative to what steps should be taken with the Irish Propositions.

Mr. Pitt last night gave notice in the House of Commons, at the conclusion of the business, when the House was very thin, Mr. Fox and others having left it, that it was his determination to form the Irish resolutions in a bill, and to pass them into a law in the present session. This will of course keep the Parliament sitting till August.

During the American war 1000l. was offered by Government for the Head of Mr. Adams, who on Wednesday last was introduced to his Majesty, as Ambassador from the United States of America.
