THEREAS by an Act paffed in this Kingdom, in the 19th and 20th Years of his present Majesty's Reign, entitled, " An Act for licenfing and regulating Lottery Offices, and other Purposes therein mentioned," it is enacted, That, the more effectually to prevent Frauds and Abuses in the selling of Lottery Tickets in Shares or Chances, each and every Ticket in any Lottery, to be established at any Time or Times after paffing faid Act, before it be divided into or fold in Shares, should be deposited with the proper Officer to be appointed for that Purpole, and that every fuch Share and Shares should be duly stamped as therein is mentioned : And that if any Person or Persons should at any Time or there are a Gree Times after passing said Act, fell or expose to Sale any Share or Chance in any fuch, Lottery or Lotteries, without fuch Share or Chance should have been first duly stamped and marked, purfuant to faid Act, that then, and in fuch Cafe. every fuch Perfon and Perfons to offending should forfeit and pay the Sum of One Hundred Pouris Sterling for each and every Share and Chance for fold or exposed to Sale, as therein mentioned.
