We are informed from good authority, that on Sunday night last, about 300 of those detested People called White Boys, assembled near Ballygarane, in this county, entered the houses of the Colony of Germans settled there, and took from thence a great number of Fire Arms.

Yesterday morning three troops of the 18th Light Dragoons marched for Rathkeale.
