John Linnahan, and Peter Lopus, for burglary, and felony, out of the house of Philip Reily, of Tipperary, to be hanged, on Saturday 10th June next.

James Condon, for a rape, committed on the body of Antlice Eakins, at Mandemount, on the 10th March, last, to be hanged, on Saturday the 10th June next.

Charles McCarthy, for horse-stealing, to be burned in the hand, and imprisoned for three months.
