But a more extraordinary instance than any of these is given by Captain Peter Bruce, who accompanied Peter the First, and his Emprels Catherine, to the borders of Perfia, on the conquest of all the furrounding Tartar nations. "Our way through Dagestan (lays Bruce) was most delightful, fixteen miles of gardens and vineyards in a firetch. The Dagestans opposed us on the heights, and feemed determined to defend their liberties. On the first day we killed 300 of those who came forward with pikes; on the fecond 200. In the flaughter of this day were men to handsome, and particularly one youth, that the Russian troops made a halt to gaze upon his beauty; by which they were fo moved, that if the Emperor had not that the leading officer, the army would not have gone on .- What form and features must that corpse possess, which retarded the progress of a Ruffian army !
