Clonmel, 31. Committed, to the County Jail, on the 28th inft, by the Right Hon. Earl of Tyrone, Thomas M'Grath and James Beckett, both of Carrick, and Mathew Beckett, of Carrickbeg, charged with having affembled in an illegal manner, on Monday the 14th inft. amongst a number of people, who call themfelves Right Boys, and with having being principally active in administring oaths, and threatening the lives of fuch as refused to swear

conformable to their regulations. As a party of the light infantry of the First, or Royal regiment of foot, commanded by Lieut. Mannoch, had taken the above prisoners in charge, in order to elcort them to jail, affifted by John Cofgrave and Patrick Kennedy, conftables, they were violently attacked in the streets of Carrick by a numerous mob, who pelted them with stones from the lanes and avenues fo furiously that some of the army were very much hurt: - This treatment obliged them (for their own fafety, and the more effectual fecurity of the prisoners) to fire, though with reluctance, by which one of the mob was killed,

and are informed more of them were wounded. Last Sunday eighteen of the Right Boys were apprehended in Thomasstown, county of Kil kenny, by Lord Clifden and Mr. Langrishe, affifted by a party of light horfe, and committed to Kilkenny jail, escorted by a detachment of the 4th horte.

TRALEE, August 31.

Monday laft, the Revenue of Dingle received information, that a quantity of fmug gled goods were secreted in the house of one Nelagan, of Lough, near the harbour's mouth, for which place the Officers immediately fet off, where they arrived about three o'clock in the afternoon, and made a feizure of fourteen keggs of brandy and feven bags of leaf tobacco. About 11 o'clock the fame night, between 2 and three hundred men, supposed to be Right Boys armed with fire and fide arms, attacked the house, into which they fired several shot, when an action commenced, which was spiritedly supported by the Revenue for a considerable time, until their ammunition was expended, and the house in flames whereupon the feizure was re-taken, and the Revenue most namercifully treated.

Yesterday a letter arrived in town from Listowhill, requesting a reinforcement of the military, the Right Boys having threatened to fet fire to the town on the following night-We have not yet heard whether they attempted putting their threats into execution.
