Yesterday Mr. VIGARS, the young gentleman who had been brought up to this city, on a charge of having headed the infurgents in the county of Kilkenny, walked Teveral times up and down the Castle-yard, in company with the Town-major and Captain of the guard; a foldier followed with a drawn bayonet, all the time. - He has very much the look and appearance of a gentleman, and was dreffed in a very elegant manner. He feemed to hold constant conversation with the officers, and fmiled feveral times. The military on duty would not fuffer any person to approach any way near them .- His drefs, upon the whole, was fomewhat peculiar, and he had a banch of ribbons in each shoe, in the form of a rofe, instead of buckles .- From the circumstance of his being permitted to walk about, it is evident that the charges are not very fevere against him, or certainly fuch an indulgence would, by no means, be granted. - It is faid, that he gests his whole defence on the oath that was administered to him by the White-Boys, and also his being in danger of his life, if he did not join them .- He does not, in any manner, deny his being along with them, but fully admits the charge upon which he was taken .- It is supposed that nothing whatever can be done to him, except his being imprifoned till the disturbances are over.

The Mr. VIGARS, now a State prisoner at the Castle, is by no means the man of property or confequence, he is represented to be in most of the papers-nor is he any way allied to the gentleman alluded to ,-who, in confequence of the idea going abroad, had himfelf a private audience with a great personage upon the

fubject.

Should it be a certain fact that the French Monarque intends ceding for ever one of the West India islands to the United States of America, it may be very naturally expected that the colonists will give a valuable consideration in return, which we may suppose to be some tract of territory in the back fettlements, as contiguous as possible to Lousiana, an extended space of country belonging to France; or elfe make a cellion of some of the illands that are adjacent to the coasts of the province of New York. Should either be the case, it may prove a thorn in the fides of the Americans upon some future occasion; as in the former predicament the French would be able on some future occafron to annoy them on the Western sides of their territories; and in the latter they might deftroy their commerce by having ships of force always ready in the different ports of the islands adjoining to their shores; for notwithstanding the apparent tranquility, and even firm alliance that at present subside between them, a very trivial and unexpected circumstance might very foon diffolve the union, and kindle up the flames of war. Mullingar, Aug. 26. Last Thursday our affizes ended, when the following perfons were tried and found guilty, viz. James Campbell Edward M'Donald, Michael Gilroy, Hugh Doudal, and Michael Doudal, all for the robbery of Mr. John Brogan, of Cullenbeg as formerly mentioned. They were found guilty on the clearest evidence, by the corroborating testimonies of several witnesses, and by a most respectable Jury, notwithstanding an alibi was attempted to be proved. Several other prisoners were tried for cow-stealing and various thefts, and were acquitted, mostly for

want of profecution.

Cork, Sept: 5. Between 11 and 12 o'Clock on Monday night laft, Scofield and M'Auliffe, stopped on Bottle Hill, by five men, who faid they came from Capt. Right to Iwear them, which they did, to call on the Printer of the Cork Chronicle, and defire he would publish, a determination in them to rest satisfied with their rates for the Tythes, and that in future they would not affemble either by night or by day, but remain peaceably in their habitations, For their own fakes it were to be wished they would adhere to this refolu ion, and that the rest of their brethren would follow them in it, and not be haftening to the fatal tree, where we fear many of them will arrive, if they do not delift from their horrid practices.

Thursday night a fort of encampment of White Boys, took place on the large field near Blarney, (in which the man was executed for murder last Assizes,) -feveral thousands met, and fent out detachments into the town of Blarney, and other friendly quarters, --- Same night a gallows was erected on the lands of Dunbullog, in the North Liberties, by one of the detachments.

Last week two Clergymen of the Church of Rome, belonging to this town, hearing a gallows was erected by some of the White Boys, ment, which may be in His Grace's Power to
