Waterford, Sept. 15. Thursday se'night a cause was tried in the city court, before the Hon. The action was brought against the defendants for entering into and sealing the offices of the plaintiff, during his absence in Dublin. The trial lasted till near ten o'Clock at night, when the Jury found damages against Mr. Moore and Mr. Weekes in the sum of 125l. each, and 6d. cost. They likewise found 6d. cost in favour of Mr. Moore.

On Monday last came on at Lifford assizes in the county of Donegal, the trial of James McCulloch, gauger, and John Houston, charged by several indictments, for the alleged murder of several persons in the year 1783, in the said county, on seizing private stills; when after a trial which lasted from nine in the morning till six in the evening, they were honourably acquitted of all the indictments.

And whereas they have been much annoyed for years past by the Inhabitants of the Cellars in the main street, frying Meat and Fish at the Cellar-doors, and indeed in the Street, the Mayor strictly forbids any such practices for the future: and desires that each Huxter's Cellar shall have a small Label affixed over the entrance, with the following words *An Huxter's Cellar*,—and no other Sign whatsoever.

It appearing to the Mayor, that the Poor of this City are much imposed upon by those Persons who bring Turf for Sale from the County of Clare, in small round Baskets. He is determined that from and after Monday the 25th Inst, none such shall be permitted into Town, and that for the future they shall supply themselves with such Baskets as are made use of in carrying Turf to the town of Ennis, two of which Measure One Statute Kish.

The Publick will take Notice, that the Sedan Chairs are numbered; and the Turf-Boats measured, and that a registry of the latter will be kept in the Mayor's office, for Inspection.

As the Flagging is nearly finished, and the Winter approaching, the Mayor requests that the Inhabitants will be so very good as to have Conductors affixed to the several water Spouts, where necessary.
