

which they were charged. and to whose lenity it was owing that they were not indicted for crimes, a conviction of which would have subjected them to a much more dreadful judgment. The object of the learned Judge was attained, for they appeared penitent, and were sensibly affected by the awful solemnity of the proceeding.

Immediately after, an application was made on behalf of the Crown to postpone the trials of the Right Boys, on affidavits stating the absence of material witnesses, and that others had been suborned and intimidated by the travellers. These affidavits were canvassed with great ingenuity and ability on the other side, and as ably supported on the other, and a case determined at Carlow, by the same Judge, having been cited, it was supposed the trials would have been brought on. However, the Judge in the clearest manner, and by reasons satisfactory to every man who heard them, shewed the impossibility of bringing on the trials, consistent with the justice which was due to the public; and it having been urged, that the prosecution was carried on by government, supported by a phalanx of crown lawyers, and that therefore the contest was not by any means fair or equal, he said, that in his situation he would not consider by whom the prosecution was carried on; but inasmuch as it had been avowed on both sides to be a government prosecution, he must, as a person much interested in the peace of the nation, say he considered the interference of government highly meritorious, and that he should not hesitate to say it would be unworthy of its powers, if it had remained supine when tumults, approaching to high treason, had nearly frightened the island from her propriety: For his part, he thought that its moderate and prudent conduct should endear it to the nation, and he sincerely hoped would prevent such a deluge of blood as was heretofore necessary to stop the progress of a similar disorder; that as to the case determined at Carlow, it was totally different. — Here the counsel who cited it got up, and with great propriety acknowledged that the cases were different.
