

Among the promotions of our gallant countrymen in the service of the King of Spain, is that of Baron John Mac Kenna, Colonel of Ireland's regiment and Knight of Alcantara, a place of great trust and honour; this officer is above 50 years in the service, and much distinguished for his knowledge in military tactics.

Every day adds to the number of failures in the city—since our last, no less than three houses have stopped payment in the West end of the town—the gross amount of their deficiency is very considerable—and added to the number of bankruptcies that have previously taken place must have a very mischievous effect.

By the plan and estimate for completing the junction of the Grand Canal with the River Shannon, the whole it is computed may be finished for the sum of one hundred and thirty thousand pounds.

The famous Mr. Rowland Hill is at present in this city: he preached last Sunday evening in Plunket-street—on Tuesday evening at Usher's-Island—and Wednesday night at Bethesda Chapel. He is followed by numerous crowds to every place of worship.

In the packet of Thursday last, arrived the Right Hon. the Earl of Drogheda, Master General of the Ordnance in this kingdom, and the Right Hon. Lord and Lady Earlsfort.

Martin, the first racket player in Ireland, was brought over to England some time since, by Mr. Vernon—to play for five hundred guineas with one Davis—esteemed to be the first player in the universe—the best of five games—the first trial Davis got two games, and Martin three—of course—judgment was declared in favour of Martin—on the second trial, which was a few days ago, Martin won three guineas to one. From the number of spectators present, and the number of bets made—it is thought not less than five thousand pounds depended on the last game, in which Martin beat Davis to eight.—Martin was afterwards proposed against any man in Europe, for any sum of money—but no one took up the offer.

Last Friday se'night a gang of coiners were apprehended at Wexford and committed to the goal of that town, a quantity of counterfeit gold and silver coin being found in their possession.

Yesterday evening, a person of the name of Muldoon, for a long time a respectable clothier on the Coombe, drowned himself in a fit of despair.—The cause of this rash action cannot be well accounted for, as he was always a person who discharged every obligation in the most strict and punctual manner, and had been considered, in the dealing line, as a very honest man, against whom, no demands have as yet been offered.
