

resolution went to establish. But he did think it necessary for the House to go out its way, on a question of national importance, merely because the conduct of any particular man—was included under the general term to which it was opposed; he declared intended the resolution merely on the ground a bill.

The ATTORNEY GENERAL, in order to avoid of the debate, proposed the question adjournment; which, after some conversation, being put, there appeared, Ayes for the amendment, 115—Noes, 106—Majority for the amendment, 9.

Tellers for the ayes, Mr. Hobart, and the Hon. D. Browne.—Tellers for the noes, Sir Edward Newenham, and Mr. Curran.

WEDNESDAY, March 4.

Mr. GRATTAN moved for leave to bring in a bill for better securing the Freedom of Elections, by disqualifying certain officers in the revenue and other employments of Government on voting thereon.

Mr. BERSFORD rose, not, he said, to oppose the leave for bringing in the bill, but to give notice, that when the bill should be brought in he would oppose it in every stage.

Mr. FORBES on the other hand, rose to give the Hon. Gentleman notice, that he would support the bill in every stage, if it was similar to that which his Right Hon. Friend had brought in on a former occasion.

Leave was given, and a Committee appointed to prepare the same.

Mr. FORBES moved for leave to bring in a bill to disable any person from being chosen a member of, or sitting or voting in the House of Commons, who has any pension during pleasure or from any number of years from, or holds any office or place of profit created after a certain time under the crown, and to limit the amount of pensions.

After some conversation between Mr. Mason, Sir Henry Cavendish, and Mr. Forbes, the latter said he should probably bring in the bill in a day or two.—Leave was given.

Sir HENRY CAVENDISH observed, as this seemed to be a day devoted to the introduction of bills, he wished to know whether it was intended to introduce a bill this session for reducing the interest on money.

The CHAN. of the EXCHEQUER professed to think as favourably of that measure as ever he had done, and said he did intend to introduce such a bill in due time.

THURSDAY, March 5.

Read a second time the bill for granting certain aids to pious and charitable purposes—the bill for granting certain duties to be paid by the Trustees of the Royal Exchange—the bill for granting 5000l. to the Dublin Society—the bill for granting 4000l. to the Trustees of the Linen Manufacture and the bill for granting 6000l. to the Lord Chancellor and Judges, towards building the new Four Courts and Public Offices.
