HOUSE OF LORDS.

SATURDAY, March 7.

The House severally sat in Committee on the
bills for granting to his Majesty additional du-
ties on hides, beer, ale, &c. on cordage, &c.
on postage of letters, on malt, on coffee, on
stamps, for promoting the linen and hempen
manufacture, and the bill to punish mutiny and
desertion.—Went through the same, and or-
dered that they may be reported on Monday
next.—The House resuming.

Lord Viscount RANELAGH, from the Com-
mittee of the whole House, to whom the same
was referred, reported that they had gone
through the tobacco bill, the French treaty,
advancement of trade, loan duty and sugar
trade bill; which being read a third time,
were ordered back to the Commons.

The bill for granting to his Majesty certain
duties upon carriages was read a second time,
and committed for Monday next.

The CHANCELLOR of the EXCHEQUER,
from the Commons, presented at the bar, the
hawkers bill, the license duty bill, and the
American intercourse bill; which were sever-
ally read a first time, and ordered to be read
a second time on Monday, to which day the
House adjourned.

HOUSE OF COMMONS.

SATURDAY, March 7.

Mr. D. B. DALY moved for leave to bring
in a bill to continue an act entitled an act for
the further amendment of the law relative to
the registering of freeholders.—Leave given.—
He then presented the bill, which was read a
first time, and ordered to be read a second time
on Monday.

JOHN EGAN, Esq; Counsellor at Law, was
introduced, sworn, and took his seat for the
borough of Ballinakill, in the Queen's county
in the room of Sir William Montgomery, Bart.
deceased.

A message from the Lords by Mr Baron
Power, and Mr. Justice Kelly, that the Lords
had agreed to the French commercial treaty
bill, to the bill for regulating the sugar trade,
to the bill for regulating and extending the
tobacco trade, to the bill for the advancement
of trade, and to the loan bill.—Ordered that
the Chancellor of the Exchequer do attend his
Excellency the Lord Lieutenant with the said
bills, and desire that the same may be certified
into Great Britain pursuant to an act made for
that purpose, and then returned to this House.

Reported the bill for granting money for
charitable purposes, the bill for granting money
to the trustees of the Royal Exchange, the bill
for granting 5000l. to the Dublin Society, the
bill for granting 6000l. to the Lord Chancellor
and Judges for building law offices, and the
bill for granting 4000l. to the trustees of the
linen manufacture.—Ordered to be engrossed.

Mr. GARDINER moved, that the salary of
the Chamberlain of the Linen Hall do not
exceed, in the whole, the sum of 350l. After
a short conversation between Sir Henry Cav-
endish and the Secretary of State, this was
agreed to.

Sir E. CROFTON moved, that the proper
officer do lay before this House an account of
the gross number of houses licensed to sell spi-
rits or strong waters in the city of Dublin, from
the 25th of March, 1787, to the 25th of
March, 1788, to the 4th of March, 1789;
and also the gross number of houses licensed
to sell beer or ale in the city of Dublin for the
said time.—Ordered accordingly.

Mr. NEVILLE presented a petition from the
mayor, bailiff, burgesses, freemen, merchants,
traders, and inhabitants of the town and bo-
rough of Wexford, praying for aid to enable
