The heads of this letter were, that writer of it had no intention of entering on any elaborate, litigious, or artificial dence of his conduct; but had thought a fimple planation, fuch as he had already given, fufient; that he had a full confidence in the fdom and candour of the House, for their termination in this bufinels; that he had, in s capacity of Manager, endeavoured to act his own bonour, and his duty to the Houle, quired; that, as they had entrufted him ith fo important a charge, they ought to ive him credit for an adherence to the dictates veracity and justice; that, whatever the ecision of the House might be, he would ot commit himself by entering into a dispute ith the avowed agent of the culprit whom he ras profecuting; that, as a Member of a Compittee of Secrecy, he would not, by a minute opiousnels of detail, in answer to the accusaion against him, give the delinquent an opporunity of knowing on what documents he relied or proving what he had advanced in the course if the trial, or what affiltance he had received n collecting information that would effablish he charges against the prisoner; that he wished o know whether the House intended to remove im from his employment as a Manager; that, I they should, he would patiently submit to their fentence; but, if they should not, he would perfevere in his exertions to bring the criminal to jullice; that no momentary disfavour from the House should prevail upon him, provided he was not displaced, to abandon the profecution he had commenced; a profecution which he had undertaken from the motives of public justice; without being instigated by malice, refentment, or party views.

Mr. MITFORD hoped that Mr. Haftings might not be overborne more by the weight of his accusers than by that of his crimes. He was of opinion, that the Managers were more bound to a scrupulous delicacy and moderation in their harangues, than advocates in an ordinary Court; partly for this reason, that the Lords, from their political connection with the Commons as a House, could not act with fo much freedom or superiority towards the Managers as the Judges could towards the Counfel in inferior Courts. He thought the explanation

given by Mr. Burke was not farisfactory. Mr. Fox was willing to admit, that the Managers ought to all as ferupulous advocates, and that they ought not to rouse the passions in opposition to truth or reason. But some distinction ought to be made between a trial for a capital crime, and one for mildemeanours In the latter case, as there was no certain punishment annexed, it was persectly fair to collect all the aggravating circumstances that could be flated confiftently with truth, as the fentence would vary according to the greater or less degree of the misdemeanor. He then expatiated on the difficulties under which the Managers would labour, if the House, by their conduct on the present occasion, should withdraw their confidence from them. It would be telling them, that those who had bestowed fo much time on the impeachment, and were therefore more likely to be mafters of the fubject than the rest of the House, must be continually liable to be called upon, at the infligation of the culprit himfelf, to answer for the
