

WHITEHALL, May 20.

The King has been pleased to grant to his Most Dearly Beloved Son, Prince William Henry, and to the Heirs Male of his Royal Highness's body lawfully begotten, the dignities of Duke of the kingdom of Great Britain, and of Earl of the kingdom of Ireland, by the names, styles and titles of Duke of Clarence and of St. Andrews, in the kingdom of Great Britain, and of Earl of Munster, in the kingdom of Ireland. DUBLIN, MAY 23.

A Messenger arrived this day (21st) in the packet, landed at Dunlerry, and brought dispatches to his Excellency, reported to confirm the appointment of Mr. Mac Donnell, the British Attorney General to the Chancery of this Kingdom. [Town.]

The report is now;—and it comes from a quarter which we have reason to consider authentic, that in consequence of a talk held by Secretary Hobart with the Great Snake, Emperor P—r: the new arrangements are proposed to stand thus:

Baron Eyre to have the Seals, vice Lord Lifford, defunct.—The Attorney General to have the Rolls, vice the Duke of Leinster to be promoted, if he chuses, to a station better befitting his rank.

Mr. Wolfe, Attorney General, vice Mr. Fitzgibbon.—Mr. Toler, Solicitor, vice Mr. Wolfe.—Counsellor Johnson to the Kilmainham Bench, vice Mr. Toler.—Mr. Boyd, as first Counsel to the Commissioners of Revenue.—Captain Pakenham to the Ordnance, vice Mr. Corry promoted.—A provision of ample importance in contemplation, for a younger branch of the illustrious House of Leinster. Whatever may be the cause, we hear, the manuscripts of the late Lord Chancellor, have all been committed to the flames.

Tuesday the Bishop of Cork and Ross took the oaths of qualification as prescribed by law, in the Court of King's Bench.

Wednesday an information was tried in the court of King's-bench, against Nicholas Mahon, merchant, for altering a warrant for the discharge of certain calicoes from 764 yards to 1764 yards, and from the duty thereon of 51. 13. 3. to 10. 13. 3.—A verdict was found against Mr. Mahon; but no judgment will be pronounced until the next term.

Wednesday night, about twelve o'clock, a dreadful fire broke out in the work-houses of Mr. Thomas Badge, Chandler, in North King-street; which raged with incredible fury for more than two hours, and in that space of time consumed a large quantity of raw tallow, and manufactured goods (soap and tallow) together with all the working machinery.

the laws also read with great solemnity, had so little effect on the convicts, that they soon found means to break open the King's stores and stole some articles thereout, for which a man of the name of Barret was executed on the 27th Feb. 1788; and on the 2d of May three more were convicted of thieving, one of whom only was executed, and the others reprieved.

A convict, who it is probable was a coiner, having produced some bronze and metal resembling gold, said he had discovered a gold mine, and on condition of being sent home with a favourite female convict, he would shew it, and said that he had sold a quantity of gold to a Gentleman belonging to the Golden Grove, which was considered as so amazing an acquisition by the new settlers, that his request was granted; enquiry was made to whom the gold had been sold, and the convict replied, to a black-complexioned man.—On this a muster of all the crew had been made in his presence, but he was not able to point out the person. He still persisted in his discovery, and that he would point out the spot; on which, an officer and 20 men, were dispatched with him in search of the place.—After travelling above ten miles, he pretended to have occasion to go aside, and was permitted; but he set off by some other way back to the settlement, and told the Deputy Governor that the mine was so extensive it would need as many more men to work and guard it; on which a fresh detachment was preparing to march in aid of the first, when lo! the officer and his men came into garrison, telling how they had been tricked by this culprit. He was immediately put into irons, tried and ordered a severe flogging; between every hundred lashes he was asked relative to the mine, and he still persisted that he had discovered and knew where it was, until he had received three hundred, when he confessed the whole to be a falsehood. The convicts are treated extremely well, they get the same allowance as the King's troops, rum excepted; the women within one third of the men's provisions, with proper cloathing for both.

The Golden Grove left Jackson's Bay the 20th of November last, touched at Port Egmont, Falkland's Islands, for water. The houses there are going fast to ruin, but the ground that the English left cultivated, was in the highest perfection. A fishing ship was there, called the Audacious, with fifteen men, who suffered great hardship for want of bread or other provision, having lived upon seal fish for a long time, until an American ship put in there, and gave them some bread in exchange for seal-skins.

On Sunday last the Rev. John Collins, a Franciscan Friar of the same order with the celebrated Mr. Kirwan, renounced the errors of the church of Rome, and conformed to the Protestant religion, in the cathedral church of Cloyne.
