20] This morning, the Right Hon. John Fitzgibbon was fworn into the office of Lord High Chancellor of Ireland, and the feals delivered into his cuftody .- The oaths were administered in presence of his Excellency the Lord Lieutenant, by the late Commissioners of the Great Seal-the Archbishop of Dublin-Lord Chief Justice Carleton, and Sir Sam Braditreet.

A congratulatory address from the Irish Bar and Attornies, was this day presented to the

Lord Chancellor.

The Duke of Leinster has been dilmissed from the place of Matter of the Rolls. No fuccessor to him is yet appointed; and it is faid to be the intention of Government, when they dispose of it, to retain the patronage in

their own hands.

Though the departure of the Marquis of Buckingham for Bath, on account of his ill flate of health, is, we hear, determined upon, yet the day is not fixed, no orders for the purpole being as yet issued; his Excellency, notwithstanding his complaint, still, as we are informed, daily attends to the necessary avocations of Government.

The title of Marquis which is faid to be conferred on the Earl of Antrim, will in its patent have the same provision contained in the one possessed by his Lordship as Earl of Antrim, whereby the earldom indifferently deicends to

the male or female heir.

If more than two Marquisses are created, and for some days past it has been reported there were to be four, the Earl of Bective is certainly to be advanced to that dignity. His fervices to Administration in the Regency bufinels were prompt and perfevering; and none more firmly adhered to the Lord Lieutenant through all the changes of that eventful period. Thefe are merits not to be forgotten.

Monday last the Judges met in the Chancery Chamber, and fituck the circuits for the en-

fuing affizes.

Robert Warren, of Jervis-ftreet, Elq; is appointed Chief Examinator of the High Court of Chancery, in the room of Joshua Paul Meredith, Eiq; refigned, and William Cruife, of the King's Inn, Gent, is appointed Deputy Chief Examinator of the faid Court, in the room of John White, Elq; allo religned.

Trevor Bomford, Elq; is appointed a Six Clerk, in the room of Denis Kelly, Elq.

The Trustees of the Linen Manufacture, at their meeting on the 26th ult, adopted feveral resolutions tending highly to the interest of the staple manufacture of this kingdom, and among others entered into the following, which we impart with the more pleasure, as it is to be hoped to excellent an idea will lead to fimilar arrangements at other Boards in Great Britain and Ireland.

Resolved, That if the Chamberlain, or any other Officer attending the Linen hall, shall demand, take, or accept of any perquifite, gratuity, fee, or reward, from any merchant, draper, or other perion attending the faid Hall, he shall forfeit his faid office, and be rendered incapable of holding any office under this Board, purfuent to the provision made by law for that

purpole.

" And if, after public notice be given thereof, any merchant, draper, or other person attending the faid Hall, shall give or offer, directly or indirectly, any gratuity, fee, or reward, or make any promife of the fame, to the faid Chamberlain, or other officer attending the Hall, fuch merchant, draper, or person, shall never after be allowed any room or standing in the buildings at the laid Hall, either by himself, or by any factor or other person."

Laft Saturday the arrival of the news that the Right Hon. John Fitz-Gibbon was appointed Lord High Chancellor of Ireland gave univertal pleafure to the inhabitants of this city and county; the bells continued ringing all day, there were many other demonstrations of fincere joy, and at night a general illumination

in the City.

The Bank which is to open here next month, will not only be very respectable, but will be of great fervice to this city and neighbourhood, Punctuality in payments forms the life and finews of trade, and while the industrious, punctual man will be at all times accommodated with a temporary loan, the rich will learn that men in trade who supply them with many of the necessaries as well as luxuries of life, ought to be paid at stated periods, and not to long torgot as they generally have been in this part of the kingdom.
