

DUBLIN, JULY 7.

KING'S BENCH.
Trial of Mr. JOHN MAGEE.
Saturday, 4th of July, 1789.

At ten o'clock the Court was crowded, the Judge, Lord Earlsfort, took his seat about eleven, when the Jury were called, and the following respectable Citizens were sworn, viz.—Henry Darley, William Smith, Benjamin Clarke, Robert Magee, John Ormston, Charles Williams, Charles Ward, Edward Forbes, John Patrick, Alex Jafferys, Jun. Brind Hone, John Lynam, Esq's.

The Cryer was ordered to call Mr. Magee, to appear in Court to answer the charges that should then be made against him, but on account of some informality, Mr. Magee was not suffered to come into Court till the trial was nearly over; all the witnesses against him had been examined, and the several paragraphs read that were alledged to be libels. Mr. Magee not having employed any Counsel, and the distressing circumstance of a man's being put on his trial without being suffered to be present, no doubt, induced a Gentleman of the Law, a King's Counsel, to stand up in his behalf, when he was asked by the Judge, if he had got a license to plead on that business, which immediately silenced him,—but some time after, a Lawyer came from the Court of Chancery, it is said, by directions of an eminent Character, and addressed himself to the Bench, demanding an immediate HABEAS CORPUS to bring the Defendant into Court, which was granted.—Mr. Magee was introduced a little after one o'clock, when after a short pause he protested against the whole proceedings as being illegal, contrary to law and magna charta; that he should have been present before the Jury were sworn, to have made his objections, and to have cross examined the witnesses. As to the Jury he could have no particular objection to any one of them, but he felt for his injured Country, imperial Ireland,—he then withdrew, and the trial went on without any defence being made.

Lord Earlsfort, summed up the evidence in a short charge to the Jury, whom he informed if they believed the Defendant to be Printer and Proprietor of the papers in question, which could not be doubted from the evidence before them, they would find him Guilty.

The Jury withdrew for upwards of half an hour, when they returned their verdict Guilty of printing and publishing ONLY. The Judge informed them, that would not do, as they must either declare on their oaths, which perhaps, their salvation depended on—Guilty or not Guilty.

They again went back for a full half hour, and returned their verdict—Guilty.

So that it now rests with the Judge to pass whatever sentence he pleases next November term; however, there is very little doubt but the verdict will be set aside, and a new trial granted.

Mr. Magee was bailed out on Saturday evening, and went immediately down to Dunleary, to his sweet little children.

The King's Counsel who stood up in behalf of Mr. Magee, was Mr. A. Browne, of the College; Mr. Lysaght, of the county of Clare, was the Counsel who demanded and obtained the Habeas Corpus.
