

The Spanish Ambassador has had another consultation with the Minister, and communicated not only his own opinion, but his instructions, in a mode exciting much less apprehension than before.

The Europa man of war of 50 guns, lately arrived from Jamaica, is ordered to be paid off and laid up in ordinary. This ship has been in commission since the peace, having twice occupied the Jamaica station, with Commodore Gardner and his predecessor Admiral Gambier.

The Court of Directors have agreed to take up 31 ships for the Company's service for India this season. They are to be destined as follows: Eight to Bengal; 20 to China; two to Bombay; and one to Bengal and Bencoolen. Some of the China ships are to touch at Malras; two of them are to proceed to St. Helena with provisions and stores for the use of that island.

In addition to the above, the company have engaged the ships which are to transport the convicts to New South Wales to take in tea at Canton at 10l. per ton. This is a great saving both to Government and the Company, as the ships would otherwise have been obliged to return without any cargoes, the East India Company having the exclusive privilege of trade in those parts; and it is somewhat remarkable, that although these ships are employed on a national service, yet they are obliged to have a licence from the East India Company, their charter extending to all places astward of the Cape of Good Hope.

Yesterday the sugar-refiners of London had a meeting at the London Tavern, and in consideration of the high price of raw sugars, came to the resolution of stopping work for three weeks from Monday next.

Yesterday morning advice was received at the India House, of the Dublin, Capt. William Smith, being safe arrived off Dartmouth; she left Madras 9th of April. The following passengers are arrived in her from Bengal: Mr. Calvert and Lady; Captain John Haynes; Mr. Guy and Mr. Lacey; Miss Fowke and Miss Robertson, from Madras; Major Baird; Lieutenants Ansley, Masters, and Bayne; the Hon. Mrs. Monson; Mrs. and Miss Cummings; Miss Jane Cairns; and Messrs. Procter, Welch, Ewing and Kelly.
