We hear from Tralee in the county of Kerry, that the late inundation there, was of more service to his Majesty's Excise Revenues, than five hundred Inspectors armed *Cap a pee*, with detachments of men from all the regiments in the kingdom, assisted by the gallant Police, horse and foot, and all the Preventive Officers in Ireland—at that tremendous flood, without either the aid of a Constable, or a writ of assistance.—swept off every barrel of shebeen in the town, all the private barrels of pot ale, casks of singlings, and smuggled whiskey, as well as all the brewing pans, black pots, alembics, private stills, concealed malt, tobacco presses full of smuggled rolls of tobacco—kieves scarcely mashed, brewer-women, (for the ladies all brew there) half naked, floating about in guile tubs!—In fact, every illicit and clandestine article was clearly swept away, and carried off, not to the Custom House, but to the Lord knows whither, to the ruin of upwards of two hundred sheebeners, maltsters, and tobaccoists, as well as all the Excise Officers of the town, who have lost all their perquisites by the destruction of their unfortunate subjects, who in future, will neither be able to supply them with meat, beer, whiskey, tobacco, snuff, oysters, herrings, shrimps, perty winkles, tea, sugar, pepper, or coffee.
