On Monday last, proceedings in a cause of
considerable consequence, between Mr Price,
plaintiff, and the Corporation of the College of
Dublin, defendants, came on to be heard before
his Excellency the Lord Chancellor, on the
plaintiff's petition, praying leave to traverse
the findings on an inquisition in 1759, whereby
certain lands in the county of Wicklow, were
found to have been devised by the last will and
testament of Dr. Baldwin, formerly Provost of
Trinity College, Dublin, to the Provost, Fellows
and Scholars of said College—when after very
extensive pleadings, and a speech delivered by
the Chancellor, replete with sound equity and
great legal language, his Excellency decreed—
that the plaintiff should be at liberty to traverse.

Same day, the Attorney General, on the
part of the Crown, moved for a conditional
rule for an attachment to issue against John
Magee, for two publications, of the 15th and
17th of September, in a paper called the
Dublin Evening Post, of which the said John
Magee is Proprietor for misrepresenting the
proceedings of the Court of King's Bench, and
reflecting on the Judge who presided. Rule
granted unless cause in four days.

Mr. John Magee of College-green, was last
Thursday brought up to the Court of King's
Bench in order to receive judgment on the in-
formation at the suit of Mr. Higgins; when
he was remanded to the custody of the Sheriffs,
to be again brought up on Tuesday next, in
order to assign error.

Thursday, in the Court of King's Bench, an
application was made that the Court would be
pleased to name a day to hear Counsel (on be-
half of John Magee) to set aside a verdict ob-
tained against him on a trial at Nisi Prius, at
the sittings after the last term. The Court ob-
jected to hear any motion, until Magee appear-
ed in custody, and cited several cases to prove
that to be the rule, when a person had been
convicted of a misdemeanor. Upon which Mr.
Magee's Counsel moved, that their Lordships
would be pleased to order the High Sheriffs to
bring up Mr. Magee, who was then in their
custody; to this the Court assented, and in a
short time Mr. Magee was brought up, in cus-
tody of Mr. Sheriff Vance; when, after a va-
riety of learned arguments of Counsel on both
sides, the Judges unanimously rejected the ap-
plication, as militating against the established
and known rules of the Court (Magee having
had sufficient time, and not availing himself of
it); but observed, that his Counsel might move
in arrest of judgment, when, if any errors ap-
peared on the record or proceedings, the pri-
soner should have all the advantages, and asked
when the Counsel would be properly prepared.
—On Counsel mentioning Tuesday next, the
Court ordered Mr. Magee to be remanded by
the Sheriffs, and to be brought up on that day.

On the morning of the 3d instant, an armed
smuggling Cutter mounting 10 carriage guns
and 6 swivels, with a number of men, came to
anchor at Carrigholt, in the River Shannon.—
Robert Sidley revenue officer, at said place,
attempting to board her in an open turf boat,
(the Barge being gone to Limerick) was fired
at six times, at about 20 yards from said Cutter,
and pursued nine miles up the river. Notwith-
standing which Mr. Sidley, at the extreme
hazard of his life, took a boat laden with to-
bacco from said Cutter, and lodged 11 bales
of it in the King's Stores, the remainder was
thrown into the sea by said smugglers, who
have lost a property of 400 or 500l. The sea
all round the boat was full of goods, which
Mr. Sidley was prevented taking up by a great
storm.

Last Thursday Mr. O'Brien, H. C. appre-
hended at Toulerton, Mark Reddin, of Manuf-
more, in the county of Clare, farmer, charged
with killing his brother Patrick Reddin, by
fracturing his skull with a pitchfork, on the 2d
October, of which he languished till the 10th
of said month.—He was escorted to town by a
party of the Spittal Association, and committed
to the county gaol by Walter Widenham, Esq.

DIED. Last Thursday, in consequence of
a fall from his horse, the Rev. John Quin,
Prebendary of Eflin, in this diocese, brother to
Sir Richard Quin, of Adare, Bart. and brother-
in-law to the Right Hon. Earl of Ilchester.—
If ever a man lived beloved and died greatly
lamented, it was the Rev. John Quin, and
painful it is in the extreme, when we have oc-
casion to notify the death of such a worthy man.
With a liberal mind, unfettered by any narrow
opinions, he was the friend of mankind.—
Gentle and amiable in his manners, sincere in his
friendship, exemplary in his private conduct.
Strictly honourable in all his dealings; his death
is an irreparable loss to his family, and will be
felt by Society, to which he was a distinguished
ornament, as well as by the numerous poor,
whom he constantly employed in making many
useful improvements on his estate.—His remains
were yesterday interred in the family vault in
the Chancel of Adare Church.
