 Abbey, in and for the county of Limerick, the  
 31st day of July, 1790, before the Honourable  
 William Henn Esq; second Justice, and the  
 Honourable Sir Samuel Bradstreet, Barr. third  
 Justice of his Majesty's court of King's Bench in  
 Ireland, hath been laid before us, by which it  
 appears that William Lane of Manillernon, in  
 the said County of Limerick, Gent. stands in-  
 dicted for feloniously assaulting and committing  
 a Rape on Lucinda Clanchy, Spinster, of the  
 Age of Thirteen Years, the only Daughter and  
 Heiress of John Clanchy, late of Ballygoiletag-  
 hill in the said County, Gent. deceased, on the
