

Additional commissioners of the revenue were appointed—the boards of stamps and accounts were separated, and additional salaries granted to the holders of several offices. He concluded with moving.

That a select committee be appointed, consisting of members of that House, not holding any employment, or enjoying any pension under the crown, to examine whether any, or what advantages have arisen to this kingdom, from the appointment of two additional commissioners of the revenue; from the separation of the board of stamps and accounts; from the granting 500l. a year additional salary to the surveyor of the ordnance; 250l. additional salary to the principal store-keeper of the ordnance; 250l. a year to the clerk of the ordnance; 200l. a year additional salary to the clerk of the delivery of the ordnance; 600l. a year pension to General Hale, in lieu of his resigning his employment of Lieutenant General of the ordnance, in order to facilitate the succession of the present possessor; 400l. a year additional salary to the clerk of the Pipe; 400l. a year additional salary to the customer of Kinsale; and 150l. a year additional salary to the Barrack-master of Dublin; and that they do report their opinion thereon to the House.

Mr. GRATTAN seconded the motion.

The motion was opposed by

The Chancellor of the Exchequer—and supported by Mr. Staples and Sir Edward Newenham.

Mr. PONSONBY rose again, and moved, “that a select committee be appointed, consisting of Members of that House, not holding any employment, or enjoying any pension under the Crown, to enquire what advantages have arisen to this kingdom, from the appointment of two additional commissioners of the Revenue.”

The motion being seconded.

The SOLICITOR GENERAL, in a speech of some length, opposed the motion; and in order to get rid of it, he moved the question of the adjournment.

Mr. GRATTAN supported the motion with uncommon energy, eloquence and ability; as did likewise Mr. Forbes.

The motion was opposed by the Prime Serjeant, Sir Hercules Langrishe, Mr. Corry, (who defended the conduct of the Marquis of Buckingham respecting the Ordnance Establishment) Mr. Stanley (in a maiden speech) Mr. Mr. Moore, and Mr. Mason.

Mr. PONSONBY, with uncommon ability, replied to the argument which had been adduced by the respective gentlemen who spoke against the motion.

The question of adjournment was now called for, and on the Speakers putting the question the house divided, when the numbers were,

and the Rhine. Instantly, when the news was known, the Chiefs of the Paris Guard assembled, and agreed to send ten volunteers from each company, about 10,000 men, under the command of M. Gouvion. Each volunteer was to have 60 livres (2l. 10s) travelling expence; and 24 sols (a shilling a day).

By a vessel from Canada, arrived at Bristol, there is advice, that the troubles in Martinico are increased; another engagement has taken place between the 501-DISANT patriots, at St. Pierre, and the inhabitants and their slaves, as well as the free negroes and mulattoes, under the command of the Governor, the Vicomte de Damas, in which the former have been severely treated. It is reported that the town of Fort Royal has been burnt; several of the plantations have been ravaged and laid waste.

A treaty, offensive and defensive, is said to have been entered into by the Russians and Swedes.

By the junction of Poland with the Porte, the Empress will have to contend with the formidable combination of Prussia, Poland, Turkey, England, and Holland.

The Empress, proceeding in her design of rivaling us with her navy, has given orders for making the port of Revel capable of containing, at least, 50 ships of the line.

The armies of Russia are computed to amount to 300,000 men.
