The following truly melancholy accident hap- ned on the 29th ult. at Killarney, co. Kerry: woman was brewing ale, and three of her children were standing with her, one a boy of 7 years old who had just come in from school. When the wort was boiling, by some unfortu- nate accident the pan overset, and the four unhappy bystanders were more or less scalded. The boy died in about an hour, a most misfe- rable victim; but the mother and the other two childred are not in danger.

Extract of a letter from Tralee, April 2.

"We have authority to assure the public, that Sir Barry Denny, Bart. is speedily to be created a Peer. His Peerage will be first an- nounced in this kingdom. A vacancy for a Knight of Shire for co. of Kerry, will conse- quently take place.

"A few days ago was committed to jail, in consequence of surrendering himself to justice, Mr. James Sullivan, for the murder of his bro- ther, Mr. Daniel Sullivan, in Glanerough, a short time since, as mentioned in a former pa- per. A sister has administered to the prop- erty of the deceased, which is considerable.

"Same day Christopher Byrne, the deputy constable, who shot John Duggan, of Rathkeal, the 30th of September last, as he was making his escape, was committed to jail, having sur- rendered himself to justice, to take trial for said murder."

Tuesday night a young man was stopped near Baal's bridge, and robbed of a gold watch:— and same night another person was knocked down, and would probably have been murdered, had not some people come to his assistance, on which the villains fled. There is every reason to believe that these nightly depredators, are the sanguinary gang, who, a few nights before, are supposed to have put an end to the existence of an honest, industrious man (Mr. John Quilty, hatter) by knocking him down, and throwing him over the bridge. It is hoped, that speedy and effectual means will be used to apprehend this nightly banditti, and prevent their prowling on the unwary passenger.
