It was not his intention then to enter into a debate upon the report of the committee, but he was of opinon that it contained facts of too great importance to be paffed by without particular notice, and on which facts he would on a future day move fuch resolutions as should draw the atrention of the house diffinctly and particularly on them :- That committee had, he faid, flated the permanent expenditure at 500,000!. more than was flated by the committee of the year 1786, to which was now to be added by the Astement of the Right Hon. Gentleman, above even the expenditure thated by the prefent report, a fum of 866 oool, as cafual expenditure, making the total of the expenditure now voting, more than what was stated by the revenue committee of 1786, as likely to be voted for 1791, no lefs than 1,300,0001 .-This immente and alarming increase of expendivure, he faid, colled for explanation to the country, for though the expenditure had thus increased, he was ready to prove that upon an average of the last five years, the revenue, tho' under every advantage of fituation, had not rifen. With what profpect before us, could we then, he asked, add to the permanent peace establishment half a million? The alteration that rendered fuch a measure necessary, the country ought to be acquainted. He stated that three million of the national debt had been paid off, by which an annuity had been impofed upon the income of the country, by the increase of the permanent establishment. He
