In the evening his Excellency, with the Lord Chancellor, and a number of Citizens, were sumptuously entertained at dinner, by John Prendergast Smith, Esq.

At night the 28th regiment fired a grand feu de joye, and a general illumination, bonfires, &c. took place throughout the city and suburbs—The new Windmill of Philip Roche John, Esq; in the rear of his extensive and commodious stores, was beautifully illuminated—had a most pleasing effect, and was beheld, with admiration, at several miles distance.

Amidst the variety of illuminations, and other testimonies of joy, displayed on his Excellency's arrival in this city, Mr Sheriff M'Mahon's transparency, exhibited the most beautiful and elegant appearance—In his drawing room windows, on the right hand and upper part, was the Imperial Irish harp and crown, with the letters G. R. over the words "Vive le Roi." In the lower part, the Prince's plume, with the letters G. W.—Over the Earl's coronet, the letter, W. for Westmoreland.—On the left window was the Irish Harp and English Crown with the letters C. R. for Charlotte Regina, and the words "Vive La Reine"—Over the Prince's Plume with the Letters G. W. and a Barons Coronet with the letter F. for Fitzgibbon.

The whole closed with firing cannon, rockets, &c. and all departed in the utmost harmony.
