In order to perpetrate the diabolical deed with great facility, he dressed himself in a Franciscan habit, and with extraordinary gestures of feigned devotion, assisted at several churches to which his holiness resorted. His uncommon manoeuvres was at length noticed by the Pope, and not being overpleased with his physiognomy, ordered him to be examined and searched; when, to the great surprise of those present, a dagger with some well charged pistols were discovered under his holy robes. LIMERICK CATHOLIC MEETING

Sept. 23, 1792.

FRANCIS ARTHUR, Esq; in the Chair

WE the CATHOLICS of the CITY of LIMERICK, have seen with the greatest concern Resolutions lately entered into by the Protestant Proprietors of this County; wherein, notwithstanding I profess "the best wishes for us, and the fullest confidence in our Peaceable and Loyal disposition," they proceed to instruct their Representatives in Parliament "IN ALL EVENTS" to oppose granting to the Catholics of Ireland, the Right of Elective Franchise.

We lament exceedingly that any among our Protestant Brethren should appear to consider as necessary the existence of their Establishment in Church and State our eternal privation of a Right, essential to our existence as Freeman; a Right, without the enjoyment of which, we must for ever continue as we are, POLITICAL SLAVES; a Right solemnly guaranteed to by the Protestant Monarch and Legislature of Ireland at the Revolution, and for which our Ancestors, relying confidently in that security, paid a valuable consideration by the surrender of their Arms, and of every City, one hundred years ago.

We do not accuse our Protestant Brethren of the Day for the breach of Faith of their Ancestors, who in depriving our Fore-fathers of the Elective Franchise violated a Compact of the most sacred obligation; but we call upon their Justice and their Honor to make that compensation which is due to so many years patient and painful suffering, on our part, under such deprivation of our Natural Right, by not opposing or humble and dutiful Endeavours to be restored once more to the Rank of Freeman in our native Country.

But whatever opposition we may meet, and we truly shall every day meet with less, on the part of our Protestant Brethren, we feel claims upon us of so high a nature as will not allow us to desist from our present pursuit; we feel too strongly the Degraded state in which we and our Children stand, without any alledge delinquency on our part to justify so severe a stigma not to persevere in every Method, not expressly forbidden by the Law, to raise ourselves and them from an unmerited and disgraceful an inferiority.

Gathering ourselves therefore on the inalienable Right of the Subject to Petition, we have delegated Men, to confer and co-operate with others of our Catholic Brethren, in framing and presenting on our behalf, humble, dutiful, and constitutional Application to our Sovereign, and to Parliament, praying that we be restored to the Elective Franchise, and an equal share in the Benefits of the Trial by Jury.

We have not entered into this Measure lightly, or without consideration. Our grievances are not imaginary. We feel the two grand principles of the Constitution violated in our Case. WE ARE TAXED WITHOUT BEING REPRESENTED, AND BOUND BY LAWS TO WHICH WE HAVE NOT GIVEN CONSENT.

We know that the Principles thus Violated, are the inalienable Privileges of every Freeman, and trust through the Justice of the Legislature, we shall obtain a participation in these inestimable Blessings.
